REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Legislative Intent—Assembly Bill No. 72

Dear Mr. Wilson: AB 72 is a landmark, bipartisan measure meant to eliminate the practice of surprise balance billing. AB 72 ensures that patients are taken out of billing conflicts between health plans, insurers and providers when the patient goes to a contracted facility for a procedure, and unbeknownst to the patient, a noncontracted provider participates in their care. As joint authors of AB 72, we respectfully submit this letter to be printed in the Assembly Journal in order to provide clarification on the intent of AB 72, specifically with respect to the network adequacy and Consumer Price Index (CPI) provisions in this bill, and provide guidance on implementation if signed by the Governor.

AB 72 added, in part, Section 1371.31 (a) (5) to the Health and Safety Code and Section 10112.82(a) (5) to the Insurance Code. The intent of Health and Safety Code Section 1371.31(a) (5) and Insurance Code Section 10112.82(a) (5), was to affirm the provisions regarding network adequacy and geographic accessibility, and to affirm the Department of Managed Health Care (DMHC) Director's or California Department of Insurance (CDI) Commissioner's authority with respect to the relevant laws and implementing regulations. Consistent with the DMHC's August 25, 2016 letter describing AB 72 language, nothing in this bill is meant to change the health plan or health insurer's existing network adequacy obligations. However, the inclusion of this paragraph is meant to ensure that this bill does not negatively impact contracted networks which the DMHC and CDI will be able to monitor through network adequacy and geographic access requirements set forth in existing law, specifically as they relate to inpatient hospital services and specialist physician services.

Additionally, it is our intention for the CPI provision set forth in Health and Safety Code Section 1371.31(a)(2)(B) and Insurance Code Section 10112.82(a)(2)(B) to again be consistent with the DMHC's interpretation set forth in its August 25, 2016 letter. These provisions require the health plan and their delegated entities or the health insurer to provide a one-time adjustment to their average contracted rate in 2018 utilizing the CPI for Medical Care Services, as published by the United States Bureau of Labor Statistics for the 2017 calendar year.

It is my intent that nothing in Section 38562.5 shall be interpreted to preclude ARB from adopting any market-based compliance mechanism pursuant to AB 32.

Dear Chief Clerk Wilson: The purpose of this letter is to clarify my intent of specific provisions contained in Assembly Bill 1110 which directs the California Energy Commission (CEC) to include Greenhouse Gas Emissions Intensity on the Power Content Label for each retail supplier serving customers in California.

The bill directs the CEC to consult with the California Air Resources Board (ARB) for purposes of developing a methodology for the calculation of greenhouse gas (GHG) emissions intensity for individual sources of electricity (as drafted in AB 1110, Public Utilities Code §398.4(k)(2)(A)). Although the bill does not require the use of a specific methodology, or data source, for determining emissions intensity, it is my intent that the CEC's approach should be consistent, to the extent practicable, with the approach taken by ARB under its existing programs including the Mandatory Greenhouse Gas reporting requirements, Cap-and-Trade, as well as the CEC's Power Source Disclosure Program. These programs include protocols for reporting data on GHG emissions and allowing specific adjustments to compliance obligations. By conforming its approach to the ARB programs, the CEC would ensure consistent treatment amongst GHG programs administered by the state.

In my view, the bill also requires the CEC to ensure that there is no double counting of the GHG emissions, or emissions attributes, associated with any unit of electricity production in the West reported by a California retail supplier (as drafted in AB 1110, Public Utilities Code §398.4(k)(2)(E)). It is my intent that the CEC should undertake this effort to the extent feasible. I believe this bill does not require the CEC to establish a new regional accounting system for GHGs or other environmental attributes associated with electricity generation. Over time, such a system may be established through the ongoing efforts of the California Independent System Operator. However, the CEC is not obligated to develop its own system and may rely on its best efforts to prevent double counting.

It is also my intent that the obligations and requirements set forth in proposed subdivision (c) of Section 38755, including certifications, may be satisfied solely by the private entity without the need for separate action by the Contra Costa Transportation Authority.

Dear Mr. Wilson: I introduced AB 1842 to strengthen protection of California's fish and wildlife. The inability of district and city attorneys to levy a per gallon surcharge as an enforcement tool for civil actions under the Fish and Game Code hampers prosecutors in their efforts to ensure that gross polluters of our waterways are held accountable. I believe the availability of the surcharge will assist the Attorney General and local prosecutors to effectively enforce complaints that have been referred by the Department of Fish and Game.

Some have expressed concern that this legislation will result in duplicative penalties against public entities that have already been subject to monetary civil or administrative liability under other statutes for the same underlying occurrences. I authored this measure to fill a gap and provide prosecutors with adequate tools to sanction egregious violations by gross polluters. It is not my intent that entities that have already paid fines under other environmental statutes be subject to double penalties for the same violation.

Dear Mr. Wilson: AB 2116 requires the governing board of a school district or community college district to obtain reasonable and informed projections of assessed property valuations that take into consideration projections of assessed property valuations made by the county assessor before ordering an election for a bond.

The intent of this legislation is to require the school or community college district to prepare and pay for the preparation of these projections. The bill does not impose a new mandate on county assessors, the only requirement is that a county assessor's projections must be taken into consideration, to the extent available, but the projection is not limited to the assessor's projections. Therefore, an assessor would not be liable if these projections do not reflect actual valuations. The intent is not to impose a new mandate on county assessors, but on school districts to obtain "reasonable and informed projections" to ensure that districts and bond advisors base their projections on available and realistic data.

Dear Mr. E. Dotson Wilson: This letter is to express my intent in authoring AB 2153. AB 2153 creates a fund directed to clean up lead contamination resulting from a lead recycling facility that contaminated my district, as well as other potential recycling facilities in the state. The fund created by this legislation is intended to be funded by two fees on the sale of lead acid batteries in California, a one dollar fee per battery sold in California to be paid by battery manufacturers and a one dollar fee to be paid by consumers purchasing lead acid batteries.

This approach is balanced and is a product of collaboration amongst various groups advocating for clean up of the sites, as well as battery manufacturers and various industries who either use those batteries in products which are important to consumers in everyday life or those who make those batteries available for purchase by consumers.

This bill should serve as a model for achieving consensus on addressing important environmental contamination issues. It is achievable only when all groups, including environmental advocates, industry and consumers collaborate on the right solution that moves forward to clean up and address real life problems for our citizens.

I would like to express my gratitude for this collaboration on behalf of the residents of my district and other areas polluted by lead acid battery recycling, as this bill provides the mechanism for cleaning up a dire environmental challenge.

It is my intent in authoring this bill, and the Legislature's intent in approving this legislation, that rather than further delaying funding for clean up by choosing the costly path of litigation with an uncertain outcome against battery manufacturers who are not owners or operators of the battery recycling facilities that the State choose instead the collaborative approach contained in this bill. By using the guaranteed funds in this bill to expedite clean up of the lead recycling facilities, the State need not wait for litigation and the delays to the clean up. It is still the Legislature's intent that the State will go after the owners or operators of a battery recycling facility to the furthest extent under the law. The need for action is now as families face the hazards on a daily basis.

Dear Chief Clerk: My Assembly Bill 2387 seeks to strengthen consumer protection laws by aiming at the problem of counterfeit airbags. This bill makes it a misdemeanor to knowingly and intentionally manufacture, import, install, reinstall, distribute, sell or offer for sale any airbag that is counterfeit, nonfunctional or does not meet federal safety requirements.

Many vehicle repairs require the removal of an airbag to complete the necessary repair of another vehicle part and the completion of the repair requires the airbag to be reattached. AB 2387 defines nonfunctional airbag to mean “a replacement airbag that meets any of the following criteria . . . (D) the airbag is subject to the prohibitions of subsection (j) of Section 30120 of Title 49 of the United States Code”. While this definition is meant to incorporate the installation or reinstallation of airbags that are recalled pursuant to federal law, it is not intended to include vehicle repairs where the airbag is not replaced and the reattachment or reinstallation of the airbag is an incidental part of the vehicle repair.

Accordingly, I wish to clarify my intent that such reattachments or reinstallations during repairs of other vehicle parts are not subject to the criminal penalties of AB 2387.

Dear Mr. E. Dotson Wilson: I respectfully submit this letter to be printed in the Assembly Journal in order to reflect the intent of Assembly Bill 2406. AB 2406 was enacted to define a distinct type of accessory dwelling unit that warrants different requirements and procedures under the law. These units represent no additional draw on utilities and infrastructure because they maintain the designed occupancy of a home.

A junior accessory dwelling unit is defined as a dwelling that includes the conversion of an existing bedroom and maintains an interior entry. A junior accessory dwelling unit provides independent living facilities for one or more persons, including permanent provisions for living, sleeping, eating, cooking, sanitation, and parking. Cooking facilities shall be limited to an efficiency kitchen with a 1.5 inch sink drain, and without a 220 volt connection or gas service.

The intent is to provide current homeowners the flexibility to stay in their homes by offering an affordable private unit to house loved ones or local workers, including caregivers. These legal units will also allow more people to purchase homes given the additional income generated from the rental of either the junior accessory dwelling unit or the primary dwelling.

Thank you for noting the intent of this measure.

Dear Mr. Wilson: As the author of Assembly Bill 2594, I write to clarify the intent and interpretation of two provisions of the bill and request that these clarifications be printed in the Assembly Daily Journal.

AB 2594 recognizes the right of public entities that capture stormwater from urban areas, in accordance with a stormwater resource plan, to use such water before it reaches a natural channel to the extent such captured stormwater augments existing water supplies.

Although all municipalities are required to obtain a National Pollution Discharge Elimination System permit for their municipal storm sewer systems, not all municipalities furnish water to their residents, as they are instead served by mutual water companies. AB 2594 is intended to recognize a public entity's right to use or transfer that right to use captured stormwater to another entity, public or private.

Furthermore, although subparagraph (b)(4) states that captured stormwater shall not create a groundwater pumping right for captured stormwater where one does not already exist, the bill does not impose any prohibition on the creation of such a right through existing processes.

Thank you for this opportunity to clarify my intent in AB 2594.

Dear Chief Clerk Wilson: When AB 2883 was heard in the Senate Labor and Industrial Relations Committee, it was noted by committee staff that the term “managing member of a limited liability company” is not defined in Labor Code or Corporations Code, where “general partner of a partnership” is defined. Committee staff requested that this term be clarified through a Letter to the Journal by the author.

Individual owners who are empowered and responsible for managing their businesses are eligible to elect to be excluded from workers’ compensation insurance coverage. This includes owners operating their businesses as sole proprietors, partnerships, corporations and limited liability companies (LLCs). Owners of LLCs are referred to as “members” and the individuals responsible for managing an LLC are known as “managers”, according to the California Corporations Code. As used in the Bill, the term “managing member” is used to describe those individuals who are both responsible for managing the business of the LLC (managers) and are also owners of the LLC (members).

To be eligible for exclusion under AB 2883, it is appropriate to confirm that the individual is both a manager and a member.

Dear Mr. Wilson: This letter is to clarify our intent regarding the provisions of AB 1690 (Medina) and SB 1379 (Mendoza), a package of bills that requires that districts negotiate in good faith regarding minimum standards for terms of reemployment preference for part-time, temporary faculty assignments, and makes compliance with this provision a condition of receiving funds allocated for the Student Success and Support Program (SSSP) in the annual Budget Act.

SB 1379 establishes legislative intent related to those minimum standards in Education Code Section 87482.3(a)(1)(B). This letter clarifies our intent is that processes and procedures for part-time, temporary faculty assignments and evaluations in clause (iii) apply to the entire section, as they are reflected in both clause (i) and clause (ii).

In addition, we wish to clarify that it is not our intent that community colleges lose much needed SSSP funding for our students. The act of conditioning funding on fulfillment of certain requirements is not

uncommon in the Education Code. The Legislature's experience has been that if our state requirements are reasonable, colleges will step up and comply.

Similarly, it is not our intent to negatively impact employees—classified or certificated—who commit themselves every day on the job to fulfilling the mission of the SSSP. Any failure by districts to negotiate in good faith with part-time faculty should not impact these employees and the good work they accomplish in the California Community College system.

Lastly, this letter confirms that this package of bills does not authorize SSSP funds to be used for any purpose other than currently approved activities. Legislative Counsel has been consulted on this specific point, and has advised that the plain language of the bill is reflective of our intent.
