Dear Mr. Wilson: I write to clarify my intent of Section 3 of Assembly Bill 1409, which states:

The commission shall neither deny nor revoke a certificate of public convenience and necessity applied for by or issued to a telephone corporation that provides retail or wholesale telecommunications services on the grounds that the telephone corporation also provides Voice over Internet Protocol service or any other unregulated service. This section does not expand the commission's existing jurisdiction over any service or affect any provision of Section 710. This section does not give any telephone corporation any new rights or powers.

It was my intent for the term "other unregulated service" to mean services provided by certificated telephone corporations consistent with the California Public Utilities Commission (CPUC) July 7, 2008 Memorandum written by Jack Leutza, Director of the CPUC Communications Division, which classifies "Enhanced Services/ Information Services" as those services that do not otherwise require a Certificate of Public Convenience and Necessity.

The July 7, 2008 CPUC Memorandum defines "Enhanced Services/ Information Services" as follows:

"Enhanced services" are offered over common carrier transmission facilities and employ computer processing applications that act on the format, contest, code, protocol or similar aspects of the subscriber's transmitted information; i.e. provide the subscriber additional, different, or restructured information; or involve subscriber interaction

with stored information. "Information services" offer the capability for generating, acquiring, storing, transforming, processing, retrieving, utilizing, or making available information via telecommunications but does not include any use of any such capability for the management, control, or operation of a telecommunications system or the management of a telecommunications services. No CPCN is necessary to provide enhanced services or information services to the public; however, provision of these services does not eliminate the obligation for the provider to obtain a CPCN when it is also providing a telephone service.

Examples of enhanced services/information services are:

- Internet access (Broadband, dial-up, etcetera)
- · Protocol conversion
- Voicemail
- Electronic messaging
- Video conferencing
- Voice "store and forward"

Thus, it is my intent for the term "other unregulated services" in Assembly Bill 1409 to apply to those services classified as "Enhanced Services/Information Services" as described above.

Mr. Wilson: My Assembly Bill 140 would codify the definition of undue influence to mean excessive persuasion that causes another person to act or refrain from acting by overcoming that person's free will and results in inequity. However, an inequitable result, without more, would not be sufficient to prove undue influence, as the intent of the elder would remain paramount. Thus, a person remains free to dispose of his property, both by testamentary device and donative transfer, even if the disposition appears unfair in the eyes of others so long as the disposition results from an exercise of that person's free will. Unfairness is therefore to be determined from the standpoint of the elder

Assembly Bill 140 lists family members as among those with 'apparent authority'. The intent is to describe those who occupy positions of trust and who thus might more easily unduly influence an elder. The intent is not to address who might be the natural object of an elder's bounty or to draw any particular negative inference from a family member's receipt of something (whether testamentary or inter vivos) from an elder.

AB 1376 creates a one-time extension of the date of implementation to March 1, 2014 for the Division of Workers' Compensation's regulations on medical interpreters (Title 8, Sections 9795.1, 9795.1.5, 9795.1.6, 9795.3 and 9795.5). I do not intend AB 1376 to have any other impacts on regulations regarding medical interpreters in the workers' compensation system.

Additionally, by creating a compliance period and delaying the implementation of the above-discussed Division of Workers' Compensation regulations, AB 1376 delays to March 1, 2014 the authorization for an employer to decline to pay an uncertified interpreter.

Dear Members: This letter is to clarify my intent regarding the provisions of AB 1309 and specifically those relating to the definition of a "duty day". AB 1309 establishes jurisdictional thresholds, based in part on duty day contacts with the state, for California to consider the occupational disease and cumulative injury claims of professional athletes.

The definition of a duty day requires services performed under the direction and control of the employer, which necessarily includes control over the time, place, manner and other circumstances of the employee's daily work activities. It is not my intent that all service activities satisfy the definition of a duty day simply because they are consistent with a professional athlete's contractual obligations. It is instead my intent that a qualifying duty day must also involve work activities performed under the direction and control of the professional athlete's employer.

By way of illustration, a player playing for an out-of-state minor league team, who plays a game outside of California would qualify for an out-of-state duty day, but not qualify for either a California duty day or one for a California-based team. Further, the same player who works in California during an offseason day, including training and medical rehabilitation service days, would qualify for a California duty day provided his employer exercised direction and control over those services.

#### Legislative Intent—Assembly Bill No. 1229

Dear Mr. Wilson: The intent of AB 1229 is to overturn the decision in Palmer v. City of Los Angeles, which held that the Costa-Hawkins Act extended to the rental housing provisions of inclusionary zoning ordinances.

It is not my intent, in authoring this legislation, to expand the powers of local government with respect to the application of inclusionary zoning to for-sale, owner-occupied housing. The legislation includes "owners" as well as renters to make clear that the bill creates no implication that the Legislature intended inclusionary housing programs may only be applied to rental housing. Thus, the language mentions both rental and for-sale to ensure continued clarity in the law.

In addition, it is not my intent to diminish the use of concessions and incentives by local governments in negotiating compliance with local inclusionary ordinances. The legislation does not insulate inclusionary housing ordinances from incentives and concessions because state Density Bonus law (Government Code §65915) requires all local governments to provide incentives and concessions to developers that include a specified percentage of affordable housing units in their developments, including affordable units required by inclusionary housing ordinances. See Latinos Unidos de Valle de Napa y Solano, 217

Cal. App. 4th 1160 (2013) and Home Builders Ass'n of Northern California v. City of Napa, 90 Cal. App. 4th 188 (2001). Moreover, the takings clause of the constitution also requires just compensation (Home Builders Association of Northern California v. City of Napa, 90 Cal. App. 4th 188 (2001)).

Dear Mr. Wilson: I respectfully submit this letter to be printed in the Assembly Journal in order to reflect the intent of Assembly Bill 566 (Stats. 2013). AB 566 was enacted to ensure that trial courts adhere to due diligence standards before privatizing court services.

AB 566 specifically exempts certain enumerated contracts from the due diligence standards set out in the bill. In particular, the legislation exempts contracts between a trial court and other government entities. This letter clarifies that this exemption is not intended to affect county-operated enhanced collection programs or other collection services carried out by a county on behalf of a court.

Dear Mr. Wilson: I respectfully submit this letter to be printed in the Assembly Journal in order to reflect the intent of Assembly Bill 1159 (Stats. 2013). AB 1159 was enacted with measures to protect undocumented immigrants from fraud by attorneys and non-attorneys with the promises to attain a lawful status under any proposed federal act to reform immigration laws, before it is enacted by Congress.

Among other things, AB 1159 makes it unlawful for an attorney or immigration consultant to demand or accept the advance payment of any funds for services in connection with any federal immigration reform act, which has not yet become a law, that would be necessary in the preparation of an application and other related initial processes in order for an undocumented immigrant to attain a lawful status under an immigration reform act.

This prohibition would not preclude an attorney from accepting a fee for performing lawful and appropriate preliminary or preparatory work for clients, such as obtaining records and documentation, for use in applications or filings under any other immigration or other law, or for lawful and appropriate procedures or processes for determining or obtaining legal relief under other immigration or other laws. Thank you for noting the intent of this measure.
