**INTRODUCTION AND FIRST READING OF
ASSEMBLY BILLS**

The following bills were introduced and read the first time:

ASSEMBLY BILL NO. 152—Baca. An act to add Chapter 2 (commencing with Section 15905) to Part 12 of Division 3 of Title 2 of the Government Code, relating to economic development.

ASSEMBLY BILL NO. 153—Katz. An act to amend Section 99314.6 of the Public Utilities Code, and to amend Sections 20002, 20003, and 22651 of the Vehicle Code, relating to transportation, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 154—Richter. An act to amend Sections 17000 and 17001 of the Welfare and Institutions Code, relating to general assistance.

ASSEMBLY BILL NO. 155—Mazzoni, Valerie Brown, and Hauser. An act to amend Section 8686 of the Government Code, relating to disaster relief, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 156—Napolitano, Ducheny, Gallegos, Kevin Murray, and Willard Murray, (Senators Hurtt, Russell, and Watson, coauthors). An act to amend Section 472 of, and to add Sections 472.5 and 472.6 to, the Penal Code, relating to fraud.

ASSEMBLY BILL NO. 157—Villaraigosa and Speier. An act to add Section 43.3 to the Civil Code, relating to personal rights.

ASSEMBLY BILL NO. 158—Baca. An act to amend Sections 3043 and 3058.8 of the Penal Code, relating to crimes.
