Subject: Office Moves

In order to move Assembly Members and staff in a timely and efficient manner, the Assembly Rules Committee has compiled a list of items that we hope will answer some typical questions, and advise you of overall move procedures.

Office Assignment Policy

A Task Force of Rules Committee members have developed a procedure that would allow for the equitable distribution of office space. After numerous meetings, it was agreed that the most effective use of space would be to assign certain offices as committee offices, i.e. Room 3016 as the Rules Committee office. These offices would then be retained as the permanent committee office for a particular committee and, in the future, only the Chairpersons of the committees would rotate. It was also agreed that in fairness to senior members of the Assembly that the selection of their offices would be based on seniority. However, in order to facilitate a move toward a complete lottery system, the sophomore and freshman classes would proceed to select offices based upon their lottery draw. The draw will occur within the two classes (sophomore and freshmen), regardless of party, with the members drawing alphabetically. Members whose terms expire in the year 1998 are considered Sophomores; members whose terms expire in 2000 are considered Freshmen. Once the lottery is completed, each member will have a set period of time to select from a list of available offices. Once that is completed, the move will begin.

Office Move Procedure

How the move will take place is as follows:

Each office will be provided with boxes, bubble wrap and room labels. The labels will be provided to more easily identify to the movers your new location. Please clearly print your new room number, your member's last name and your full name on each label.

All offices should be packed and ready to move at their scheduled time. A schedule of expected move times will be provided.

Committee Offices

Committee Offices will be the first to move. ALL committee equipment (computers, phones, file cabinets, etc.) must remain in the designated committee office. No exceptions!! The movers will have a list of names regarding who is considered personal staff and committee staff to insure that committee equipment is not inadvertently removed.

Personal Offices

NO FURNITURE WILL BE MOVED. Only personal file cabinets, files, chairs, typewriters, computers, water coolers, microwaves, refrigerators, personal pictures, and plants will move. As bookcases will remain in your previous offices, please remember to pack all items within those bookcases. Personal office file cabinets will be moved FULL, therefore, there is no need to remove and pack files separately.

Any additional furniture needed or furniture rearranging will be taken care of after all moves are completed. Please do not attempt to move furniture on your own.

If you acquire an office without the West and Deering Code books, arrangements will be made to supply a set to you after the move has been complete.

Personal Staff Computers

Computers will be the first items moved from your office. It is important that you log off and have your equipment labeled. Your computer will be reinstalled in your new *permanent* office. PLEASE NOTE: INDIVIDUALS PLACED IN A TEMPORARY SPACE WILL NOT HAVE COMPUTER ACCESS.

Once you have reached your permanent location, please be sure that your computer is set up in its proper location in the office. This will help cut down on computers having to be relocated later. Printers will NOT be moved.

Also, please inform District Office staff that during the move, there may be a delay in service when contacting the help desk. Due to the magnitude of the move, a large majority of the ACS staff will be working on the move in the Capitol building. Therefore, please be patient!!!!

(NOTE: CLEARLY LABEL CPU, MONITOR, KEYBOARD, AND MOUSE WITH YOUR FULL NAME AND NEW OFFICE NUMBER.)

Telephones

Phone and fax lines will be moved in conjunction with your office move. Please do not move any of the phones, fax machines, squawk

boxes, or answer machines on your own. Telecommunications will handle all moves. However, please note that each member will retain their same phone and fax number.

Voice mail will be up and running as soon as possible. Also, headsets are considered personal items that should be moved to your new location with other personal supplies.

Again, please remember to label all equipment with your new room number, member's last name, and your full name.

Keys

ALL offices will be re-keyed by the Sergeants office. You will be re-issued keys as soon as possible. If, in the event you are locked out, the Sergeants will open your door for you with a valid Assembly ID card.
