ASSEMBLY BILL NO. 189—Hauser. An act to repeal and add Part 1.5 (commencing with Section 34000) of Division 24 of the Health and Safety Code, relating to redevelopment.

ASSEMBLY BILL NO. 190—Frusetta. An act to amend Section 190.2 of the Penal Code, relating to murder.

ASSEMBLY BILL NO. 191—Cannella. An act to amend Section 1808.4 of the Vehicle Code, relating to public records, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 192—Cannella. An act to amend Section 11713.1 of the Vehicle Code, relating to vehicles.

ASSEMBLY BILL NO. 193—Kevin Murray. An act to amend Section 10115.2 of the Public Contract Code, relating to state contracts.

ASSEMBLY BILL NO. 194—Kevin Murray. An act to amend Sections 6051, 6201, and 17041 of the Revenue and Taxation Code, relating to taxation.
