He was defined by friendship with the great men of his day: Kennedy, Truman, Stevenson, Warren, just to name a few.

He gladly planned and freely spent state money for new campuses promoting sciences and liberal arts.

Realizing his conviction that prosperity for any state depends upon the good work educators do.

Freeways, aqueducts, dams, universities and parks compose

The legacy he leaves for grateful hearts.
