Members of the Assembly: As required by Chapter 16, Statutes of 1990, the Bureau of State Audits presents its audit report concerning the State's allocations and expenditures of transportation funds generated by the 1989 Transportation Blueprint Legislation. This report concludes that the State allocated and expended transportation funds in accordance with statutory requirements. It also concludes that revenues anticipated by the legislation from increased taxes, weight fees, and bond proceeds will be approximately \$3.4 billion less than the \$18.5 billion anticipated by the legislation.
