Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit concerning the Department of Health (department) administration of the California Medical Assistance Program (Medi-Cal) supplemental drug rebate program (program). This report concludes that the department has not collected approximately \$40 million in rebates related to the 1994 legislation amending the State's supplemental program. Because it has not adequately administered this program, these amounts are owed to Medi-Cal by drug manufacturers under contract with the State. Furthermore, the department cannot clearly demonstrate that it conducts reviews of drugs to modify the Medi-Cal List of Contract Drugs in accordance with state law. In addition, the 1994 legislation has not significantly reduced the availability of drugs to Medi-Cal recipients. Finally, the annual costs of approximately \$5 million to administer the program are far exceeded by potential program revenue of approximately \$70 million.

Members of the Assembly: As required by Chapter 518, Statutes of 1995, the Bureau of State Audits presents its audit report concerning Los Angeles County's fiscal condition. This report concludes that to balance its fiscal year 1995–96 budget by year-end, the county needs federal approval of a \$346 million health relief package, and departments must meet a 20 percent reduction in net county cost. Future budgets will also be difficult to achieve because the county will need additional funding to implement the Three Strikes law, repair county-owned buildings damaged in the Northridge earthquake, and implement state and federal welfare reform.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the progress of the Department of Insurance (department) to improve the management practices of its Conservation and Liquidation Office (CLO). Specifically, we performed a follow-up review of our May 1994 audit of the department's conservation and liquidation operations concerning management of conserved insurers, personnel practices, contracting, allocation of costs to conserved companies, disposition of assets, and claims processing. This report concludes that although the CLO has developed a strategy and management plans for the conservation and liquidation of conserved insurers, it has achieved limited success in distributing the assets of liquidated insurers and closing their

estates. We noted certain events that may have prevented the CLO from closing more estates than it did. As a result, we could not determine whether its strategy and management plans have been effective in maximizing the assets of conserved and liquidated insurers. In addition, the CLO has not fully implemented its policies and procedures for conservation and liquidation activities. For example, the CLO has not adequately monitored its budgets, or frequently updated its plans for closing estates. We also noted the CLO's ability to identify and pay claims is impeded by incomplete records and claims which are not readily proven by claimants and allowed by the courts.

Although the CLO has made significant strides to develop its administrative practices, further improvement is needed. For example, it does not always follow its policies and procedures for hiring employees and managing consulting contracts. In addition, the CLO has not established guidelines for borrowing from its investment pool to fund the costs of administering no-asset estates.

#### **Battin Floor Statement**

Mr. Speaker and Members of the Assembly—It is with great pleasure that I introduce the Native American guests joining us today for Native American Indian Week. Elected leaders of the many tribal governments of California are represented here today.

I also want to introduce the Hoopa Valley Indian Reservation dancers and their tribal Chairman, Dale Risling, who will be

performing for us this morning.

In my district and throughout California, tribal governments have demonstrated a long tradition of promoting responsible self government, preserving their heritage and working to make their tribal communities and our state a better, more prosperous place to live

Tribal governments have fought hard to build responsible businesses, and to use their economic successes to improve life on

their tribal lands and in surrounding communities.

Tribal government's economies are contributing hundreds of millions of dollars in jobs, goods and services to California's economy. And tribal governments are working to eliminate welfare on their reservations, fund desperately needed public services, and support worthy local causes.

And with their economic success, tribal governments have not lost their strong sense of community. If anything, their economic success is empowering them to become even stronger, more dedicated members of the communities in which they live.

My children attend day care at the Cabazon Indian reservation near Indio—a program that is known to be one of the best in my

community.

The Sycuan government in San Diego is providing health care to tribal members and residents of the surrounding community—and using reservation income to underwrite the costs of those services by 75 percent.

The Viejas reservation is expanding fire protection to become the first line of defense for non-tribal residents in nearby communities.

Also in San Diego, the Barona tribal government made a significant multi-million dollar contribution to Children's Hospital in San Diego.

The Rumsey Rancheria in Yolo County has signed a cooperative agreement with the County Sheriff to finance two additional law enforcement positions to patrol the entire Capay Valley, and purchased a patrol care as well.

And the Hoopa reservation reached a similar agreement with Humboldt County to fund desperately needed law enforcement.

These are but a few examples of the kind of good work, community spirit and real leadership tribal governments are demonstrating throughout California today.

Native Americans have a proud history—and with their business success and dedication to community service—they are sure to have

a proud future.

I'm proud to introduce leaders from some of California's tribal governments today. Please join me in giving them a hearty welcome. And please join me in the Speakers' Conference Room for a reception to meet with the tribal leaders.
