On April 24, 1995, Gil Murray, the President of the California Forestry Association, a dedicated father, a respected professional forester, and a true gentleman in every sense of the word, was consolerable and the sense of the word was consolerable and the word was con

forester, and a true gentleman in every sense of the word, was senselessly murdered by a faceless killer known only as the Unabomber. The day will be forever etched in my mind not only because of the loss of someone I personally found to be both friendly and professional, but because stakeholders on all sides of the forestry debate lost a man of understanding, a builder of trust, with an unwavering commitment to the productivity and conservation of our forest resources.

As the events of the past few weeks have unfolded with the capture and arrest of Theodore Kaczynski as the alleged Unabomber, the underlying tragedy has become supplanted with a frenzied atmosphere about evidence, manifestos, sightings, and lifestyles. Certainly the staff at CFA is both thrilled and relieved that this

person has been taken into custody, and none-to-soon with his apparent plans to bomb other forestry officials in the Pacific Northwest.

But with this man now in custody, and as we approach the one year anniversary of Gil's senseless murder, it is once again time to reflect upon the human side of this story . . . a father gone, a forester lost. At a time when there was more confrontation than collaboration. Gil reached out to both environmentalist and resource industries to try to find common ground on very acrimonious issues. His many activities included being the driving force in establishing the Fish. Farm, and Forest Communities Forum in California that is trying to find collaborative solutions to the problems of declining salmon populations as well as restoration and enhancement of aquatic habitats. He was also the former Forest Manager for Collins Pine Company in Plumas County, where he managed a forest that has since been recognized by the conservation community for its outstanding management practices. Gil will also be remembered by many for his continuing allegiance and interest in his sons' school and athletic activities, his alma mater UC Berkeley, the United States Marines, snow skiing whether it was for fun or competition, and the consumption of mass quantities of chocolate.

So I ask that we adjourn today in memory of a devoted and loved husband, father, brother and son, admired friend and respected professional forester, Gilbert Brent Murray. In addition I ask that you all join me in further honoring Gil by giving recognition to the fact that people and their environment are inextricably tied together . . . and that solutions that advocate or use violence in any form must be soundly rejected by wearing a green ribbon this Wednesday, April 24, the anniversary of Gil's untimely and truly senseless death.
