MESSAGES FROM THE GOVERNOR

**Governor's Message
Reorganization Plan No. 1 of 1995**

Dear Assembly Members: It is my pleasure to submit to you and the Legislature, Reorganization Plan # 1 for 1995. The plan calls for the consolidation of the Division of the California State Police into the Department of the California Highway Patrol (CHP). The plan is being submitted to you in conformance with the provision of Section 12080.2 of the Government Code.

Reorganization Plan #1 will combine two law enforcement functions into one department. Currently, the California State Police fall within the organizational structure of the Department of General Services (DGS). This reorganization plan will move these responsibilities from DGS to the CHP. I believe combining these law enforcement activities will benefit both organizations. It will provide enhanced services to state employees, the public being served at state facilities, and provide improved security for state properties. Given recent events elevating concerns regarding Capitol security, the Legislature may wish to give expeditious consideration to the proposed reorganization and its potential for positive impacts on safety. The consolidation of these two functions will also promote some cost savings to the State of California. The reorganization plan was submitted to the Little Hoover Commission. The Commission evaluated this reorganization on March 16, 1995 and subsequently, recommended its approval by unanimous vote.

I believe the Legislature will find the consolidation of the two organizations will be more efficient and effective than the current arrangement. It is my hope for this change to be effective as soon as the statutory provisions allow. I, therefore, ask that you take the appropriate steps to ensure its introduction to the Legislature.
