We are writing in support of AB 3432.

The Tuolumne county School Attendance Review Board is composed of representatives from local school districts and community agencies. The Board meets regularly to combine their expertise and resources on behalf of the students referred to them for ruancy. The goal of SARB is to keep students in school and provide them a meaningful education experience.

Over the years, our records indicate that a majority of habitually truant children in Tuolumne County are from familles receiving public assistance. Regular school attendance is essential for these children but often is not a priority of their parents. Our current education system provides many assistance programs such as Special Education Resource Assistance, Chapter I, free and reduced rate lunches, etc., which these children often need but can only get if they attend school regularly.

Anything that can be done to assure these children receive an education would be a giant step in welfare reform. Education opens future opportunities for children from any economic background.

We strongly disagree with the statement of the Friends Committee on Legislation that "this bill will do little to stop truancy." Those of us who work with truant children feel that it will serve as a great deterrent to truancy by providing an incentive for children to be in school.
