#### Legislative Intent—Assembly Bill No. 971

Dear Mr. Speaker: This letter is to clarify questions that have been raised as to the authors' intent relative to Chapter 12, Statutes of 1994

(AB 971) and its implementation.

AB 971, the Three Strikes and You're Out law includes a provision that ensures that the sentence prescribed in the legislation is appropriate to the crime and the criminal history of the defendant. The law states that the sentencing provision mandated by AB 971 shall be implemented in all cases except as provided for in Penal Code Section 667 (f) (2) which allows the prosecuting attorney to move to dismiss or strike a prior felony conviction allegation "in the furtherance of justice . . .".

Assembly Bill 971 provides for the striking of prior convictions in some limited instances, but it only authorizes such action to be initiated by the prosecuting attorney and subsequently ruled on by the judge. AB 971 does not allow judges to strike prior convictions on their own motion, unless there is insufficient evidence to prove the prior conviction.

In two separate places, the legislation requires judges to implement the sentencing provisions of the law without dismissing prior convictions on their own motion. Penal Code Sections 667(c) and 667(f) (1) both speak to this point.

Although judges were denied this unilateral discretion on the striking of prior convictions under AB 971, they still maintain their traditional authority to determine the base sentence for the

calculation of second and third strike sentences.

AB 971 is silent regarding the charging of "wobblers" as either felonies or misdemeanors when that designation would affect the implementation of Three Strikes sentencing. Previously existing law is still applicable.
