MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 1436

Governor's Office, Sacramento June 3, 1996

To the Members of the California Assembly:

I am returning Assembly Bill No. 1436 without my signature.

This bill would require health care service plans and disability insurance policies, beginning January 1, 1997, to reimburse fire departments for their first responder services. The bill would also require the Medi-Cal Program to reimburse for these services. Additionally, this bill would require the Medi-Cal Program to increase rates for ambulance transportation services.

This bill would result in persons with health care coverage subsidizing tax supported emergency services. The cost of operating fire departments and emergency services is paid by all taxpayers. Those taxpayers with health care coverage would be required to pay twice in the form of higher health care premiums to cover reimbursement for first responder services provided by public agencies.

In addition, the cost of this new mandate would disproportionately fall on small businesses and individuals. Self-insured health plans, usually sponsored by large employers, are exempt from state mandates.

Finally, this bill would create a new Medi-Cal benefit. Because federal financial participation would not be available for this added service, this new benefit would be supported by the General Fund only.

AMERICAN DEMOCRACY

American Democracy is an unique form of government where the people decide how they live their lives. Democracy was based on beliefs, truths, ideas, and philosophy. The peoples' government is flexible enough to change with current political, economic and social conditions of the United States of America. Our government only has the power that we allow it to have.

The founders believed that all men are created equal. If one person has more money or property than another, "all men are created equal", doesn't mean take from one to give to another. Created equal means all men have the same opportunity to achieve the same things.

All men are born with certain unalienable rights. All people have the right to live without fear of being injured or killed by another person. All men have the right to believe what they want, read what they wish, say what they wish, and travel where they wish. All men have the right to own material things. These three rights are also known as Life, Liberty, and the pursuit of Happiness. Some founders believe you get these rights from God, others believe it's natural to have them.

The colonists who came here prior to the 1760's felt it was time to cut off ties with Britain. King George III of Britain decided to tax the colonists, stop their trading with other countries, he kept his army in the colonies during peace time, and he refused to approve the laws which the colonists made. The colonists felt that the Kings actions threatened their right to govern themselves. In April of 1775 Britain and the American Colonists began the American Revolutionary War. When the war ended Britain had no governmental control over the American Colonists.

The founders of the Constitution of the United States and the Declaration of Independence believed that a Republican Government had great advantages. The laws made by Congress would be fair, if they weren't the people could elect a different representative from their state. The laws made would help everyone, not just a few. People would be able to have freedom to live well. A Republican Government was the best kind of government.

When our founders drafted the Constitution there were two main things they needed to make sure of. They never wanted the government to have more power than the people. The founders also never wanted to take away the peoples' God given rights. An American Democracy was created while allowing the people to keep the power and rights.

Our Republican government was created with limited power. The government was divided into three branches, the legislative, executive and judicial. The legislative branch makes our laws. The executive branch enforces the laws. The judicial branch settles

disagreements about the laws. With three branches of government, no one branch will ever have more power than the people. This type of system is also known as checks and balances.

The most important branch of our government is the legislative branch, which is also known as congress. The people in congress are the representatives we have elected from each state. Congress is made up of the Senate and the House of Representatives. The Senate has two representatives from every state. The House is determined by each states population. No law can pass unless a majority of both, Senate and House, voted in favor of it.

The executive branch of government is the President. The President can only serve for a maximum of 8 years. After Congress passes a law the president can sign it or veto it. If he signs it will become law. If he doesn't sign it, both the Senate and the House must get a ¾ majority vote to over ride the Presidents veto. If Congress gets the ¾ votes the bill becomes law.

The judicial branch of the government is known as the Supreme Court. The president appoints these judges, Congress must approve the appointment. The Supreme Court settles disagreements about the law arising from the Constitution. The Supreme Court can stop a law from going into effect if it violates your God given rights.

A good constitution and good leaders are not enough. We, the people have a responsibility to fulfill. We must participate in the peoples' government to ensure that our rights are protected. It is every citizen's responsibility to vote when they reach the age of 18. You are free to choose what type of citizen you will be, and what kind of society you will live in. More importantly, it is every mans responsibility to leave a free country for the future.

All "citizens" of the United States of America, are the people. We the people, elect the people to run our government. American Democracy is a government of the people, by the people, and for the people.
