**TOWARD A PAX PACIFICA**

A Speech of

**I. DAWNING OF THE PACIFIC CENTURY**

Ladies and gentlemen:

This is a great honor, to be invited to speak before the Legislature of the American state most closely associated with my country, some 6,000 miles westward across the Pacific, a major pillar in the building of America.

Before there was a United States, California and *Filipinas* were joined together by the Spanish galleons trading between East Asia and the New World.

For 250 years, starting from the 1570s, the great galleons sailed between Manila and Acapulco. Their American landfalls, after the dangerous voyage that often lasted eight–nine months, were what are now the great cities of the California coast, Monterey, San Diego, Los Angeles, Santa Barbara, San Francisco.

Then, in the nineteenth century, the very same spirit that colonized California encompassed my country. The pursuit of Manifest Destiny that tamed the American West also overran the Philippine archipelago.

In our own time, these historical ties are being strengthened even more by the amazing growth of the Pacific Rim economies.

The world's economic and political gravity is tilting to the Asia-Pacific so decisively that knowledgeable people predict the coming of a "Pacific Century."

What are the indicators of this Pacific Century?

More than half the global GNP for the decade of the 1990s will be produced in Asia. In 1990, America's trade with East Asia exceeded its trade with Europe for the first time. By the year 2000, trade and investment flows across the Pacific should be double the volume of trade and investment across the Atlantic.

Within ten years from today, there will be more people in the ASEAN region with an American standard of living than there will be in America. Imagine that!

The Pacific Ocean has historically been a great highway—bringing our two continents together. In our time, its linkages are even more secure—because they are supported by the new communications technology and the international division of labor.

## II. CALIFORNIA AND THE PHILIPPINES IN THE ASIA-PACIFIC ECONOMY

As late as 1852, Daniel Webster, then Secretary of State, arguing against the Westward drive of the American Republic, had questioned what it would do "with this worthless area, this region of savages and wild beasts, of shifting sands and whirlwinds of dust, of cactus and prairie dogs."

"To what use," he asked, "could we ever hope to put these great deserts and these endless mountain ranges?"

What a mighty answer California has given Daniel Webster!

Because the pioneer spirit is an entrepreneurial spirit, California has become the agricultural and industrial power of the United States—responsible for America's world leadership in aerospace, agribusiness, semiconductors, microcomputers, genetic engineering and laser technology.

In fact it is said, if California were to secede from the Union, it would become the seventh biggest industrial power on earth!

And now California, which has always faced the Pacific, also connects the American Republic to the region that will be the motive force of the world economy in the twenty-first century.

California the favored destination of Asian migrants

This early, the airports of the West Coast have become the new Ellis Islands for the new wave of migrants "yearning to breath free."

California is where the rainbow ends for migrants from East Asia. Since 1965, when U.S. quotas favoring European migrants were abolished, there has been a leap in Asian migration. Between 1990 and 1995, the number of Asians and Pacific Islanders in California increased by more than a third.

And the people of this second migration are not the manual workers and indentured peasants of the first Asian migration a hundred years ago. They are professionals, engineers, doctors, scientists, or entrepreneurs, hard-driving, education-oriented, competitive—and they carry capital with them. I understand there are some 30 Asian banks established in California, and an estimated \$27 billion in Asian investments.



These new Asian-Americans are helping along California's geoeconomic alliances across the Pacific. California's share of American exports, now 16%, is rising steadily, and two-thirds of it is destined for East Asian ports.

My own country is stirring in East Asia

Like California, my own country is being deeply affected by the vigor of the East Asian economy. As a rising tide lifts all boats, so has the buoyant East Asian economy raised the level of Philippine economic growth.

The Asian Development Bank projects Philippine real GNP to grow by 6% this year and 7% in 1997. What is more, our growth, under the leadership of our great President Fidel Ramos, now is led not (as in the past) by public spending but by exports and private-sector investment. Over January-March, our real GNP grew by 6.2%.

Foreign investment is pouring into Subic Bay and Clark Field—once the home-bases of the Seventh Fleet and the Thirteenth Air Force. Thanks to the infrastructure the American military left behind in 1992, the two bases have become attractive export zones. In 1993, for example, Subic alone attracted \$300 million in direct foreign investment—20% more than the entire country had attracted in the previous year.

Reebok International is already in Subic: So is Federal Express, which has chosen Subic Freeport for its Asian hub.

Nynex is in telecommunications, and Intel is investing \$200 million to increase the capacity of its memory chip and microprocessor plant. Avon has a Southeast Asian manufacturing hub in the Philippines; and Proctor and Gamble are planning a \$100 million detergent plant.

Even American television is voting for the Philippines. The new American television program INVEST/America has named my country as one of the best in the world for foreign investors!

Yet Philippine growth is just beginning to accelerate—the economy is just gearing up for the “cruising speed” of 8-9% that our East Asian neighbors easily attain.

Politically, we in the Philippines are trying to construct a new politics—a democracy that will make the system benefit not just the political elite, but every citizen equally.

Relations with American are still “special”

The relationship between our two countries has changed a great deal since the Seventh Fleet sailed out of Subic Bay three years ago. But for us Filipinos, our shared belief in liberal democracy—and the Filipino-American community (America's largest ethnic-Asian population)—ensure that relations between our two countries will always be “special.”

America is still our top trading partner—we still have a mutual defense pact—and we look to American investments to balance investment coming predominantly from East Asia.

In foreign relations, our foremost concern—in cooperation with our neighbors and partners in ASEAN, the Association of Southeast Asian Nations—is to preserve the benign regional environment.

This is the object of the ASEAN Regional Forum—founded July 1994—which gives all the East Asian states—plus all the outside

powers (like the United States, Canada, the European Union and Russia) with legitimate interests in the region—a forum for settling multilateral security issues.

This November, the Philippines will host the APEC Leaders Summit: 1996, by the way, is also the centennial of our nationalist revolution of 1896 against Spain—which produced East Asia's first free Republic.

### III. TOGETHER LET US WORK FOR A PAX PACIFICA

Following America's recession from its Philippine bases in 1992, fears of a power vacuum had been widespread in East Asia. But we in the Philippines never for a moment believed the United States would pull out of East Asia. Isolationism is impossible for such a great power in the era of the intercontinental ballistic missile; the communications satellite, and the worldwide cultural revolution.

Demography, commerce, and national security bind America irrevocably to the Asian continent. And it can no more accept an East Asia dominated by a single power than it could a Western Europe dominated by Hitler's Germany or Stalin's USSR.

No, we in the Philippines do not think the United States has any alternative but to take part in the organization of a Pacific peace, a peace along both rims of the ocean we share, a *Pax Pacifica*.

The Pacific peace needs American leadership

This Pacific peace that all our peoples envision needs American involvement, just as East Asian stability, to which the region owes its amazing growth, needed its underpinning of American military power.

Throughout the post-World War II period, the United States has not only been the crucial guarantor of East Asian stability, it has also been the main export market for East Asia's commodities.

Throughout the Cold War, the United States has been the fulcrum of the Asia-Pacific balance of power—the great power whose constructive involvement is accepted by every other East Asian power, because it has no hegemonic ambitions.

There is a tremendous reservoir of goodwill for the United States in East Asia, on which a post-Cold War relationship can be built.

At a conference of the Asia-Pacific Parliamentarians Union (APPU) in Manila which I had the privilege to chair, I said that in the event the more than 40 countries on the Pacific Basin decide to form a union, a common community, they would exercise a decisive and implacable influence on the course of human affairs.

The countries within the scope of the Pacific Ocean constitute mighty force for good without any possible match or parallel in the world. In terms of manpower, natural and human resources, existing and probable wealth, moral, spiritual, and material strength, and achievements, the Pacific countries surpass, collectively, all other countries on the face of the earth.

Let me reiterate and stress two points I raised at the APPU conference in Manila:

*Pax Pacifica* would embody the finest and best of the culture, the political, social, and economic systems of three continents, the

highest levels of science and technology in the world, and infinite wealth of spiritual faith.

Pax Pacifica to Excel Romana and Britannica

Pax Pacifica would be an ideal point of convergence for the great religions and civilizations that have flourished throughout the ages.

Pax Pacifica would, in fine, be the incarnation of the quintessence of the priceless and imperishable heritage of the peoples of Asia, North America, and South America.

That would be a high point in the story of the world that could well excel the grandeur of Pax Romana and the glory of Pax Britannica.

Already, the fulcrum of leadership in the economic world is perceptively shifting from the Atlantic to the Pacific. When Pax Pacifica is organized, and the 40-odd countries within the Pacific littoral are integrated into an economic union, the sun of world civilization will rise anew in the Pacific "from whence it sprang, in God's good time, in its pristine glory."

Cultivating the concept of a Pacific Community

The idea that Asia-Pacific countries have both a national and a regional interest has taken some time to establish itself. But we in the Philippines believe it is growing in our midst. And we need to cultivate it, if our Asia-Pacific community is to deal with problems beyond the competence of any single nation.

This early, it seems obvious that lasting peace among our countries cannot be founded on the hegemony of any single power. The age of empire is gone forever. Pax Pacific must be founded on the idea that every state in the region, no matter how small, has something valuable to add to the whole.

John Donne, the great English poet, taught us that "No Man Is An Island." In the Pacific, we are learning that no state is an island either. Working together, and with America as our partner, we can make the Pax Pacific the greatest engine of economic and social progress since the Renaissance and Reformation. We can carry John Donne into the 21st Century.

Asia-Pacific unification will be managed by regional institutions like APEC and the Asean Regional Forum. Certainly, the free market must also be a vital component of a Pacific peace—as an instrument for liberating the spirit of enterprise and encouraging the rise of civil society. But we should insist that Asia-Pacific capitalism have a care for those social groups that development leaves behind.

Unhampered cultural exchanges too we must encourage, so that they can generate a synergy—compounding the best of East and West into a new Pacific civilization.

Genesis of a new Pacific culture in California?

American society has always been distinguished by its ability to take people of widely different backgrounds, cultures, and faiths—and assimilate them to the American ideology: a shared faith in a self-governing polity of citizens, secure in their individual freedoms, and equal in their opportunities.

Perhaps this can be the model of a new Pacific culture—cross-fertilizing American, Japanese, Chinese, Malay, Korean cultures. And perhaps its genesis will take place in California,

whose overwhelming influence on the international popular culture has moved some social commentators to speak of the “*Californiaization* of the Free World.”

*Ladies and gentlemen of the California Assembly—*

So far the idea of a Pacific Community is just a vision we share, a dream nurtured by fraternal activities that bring us together from different parts of the Asia-Pacific. So far our economic interaction has proceeded faster than our political cooperation.

We should focus on closing this gap. Because if our political cooperation does not move forward, then inertia will begin to work against us. And our political and security problems will begin to stall our economic growth.

Finally—In this work of creating a Pacific Community, East Asia looks to America for substantive participation and counsel. We Filipinos, in particular, continue to look, beyond trade and investments, to the idealism which has always been the mainspring of American foreign policy.

We regard America as the ultimate guardian and pillar of peace in the Pacific—of lasting peace that will enable our peoples to “ripen into all the excellence and all the dignity of humanity.”

Thank you for the hospitality of this Assembly. Long live the Philippines and America!
