**RE: Governor's Reorganization Plan #2—Energy Programs**

Dear Mr. Wilson: Government Code Section 12080.2 requires the Speaker of the Assembly to refer an executive reorganization plan to a standing committee of the Assembly for study and report. The law further requires that the committee shall issue a report, which may include a recommendation for a resolution in support or opposition to a plan, at least 10 days prior to the date on which a reorganization plan would otherwise take effect.

The Governor has submitted the Governor's Reorganization Plan (GRP) #2, which abolishes the California Energy Commission, transfers its function to the Department of Conservation, and makes other changes to energy law and programs.

Since, under the Rules Committee's jurisdictional guidelines, matters affecting the Energy Commission fall within the jurisdiction of the Natural Resources Committee, I respectfully request that you refer GRP 2 to that committee for review and study.

**Legislative Intent—Senate Bill No. 51**

June 12, 1995

*The Honorable Speaker of the Assembly and  
Members of the Assembly:*

The Legislature's intent in enacting SB 51 is specifically the following:

1. Code of Civil Procedure Section 1036 is made applicable in appellate proceedings to conform Section 1036 to what the California Supreme Court has held is "the general rule that statutory attorney fee provisions are interpreted to apply to attorney fees on appeal unless the statute specifically provides otherwise." (*Morcos v. Board of Retirement* (1990) 51 Cal. 3d 924, 929. *See generally* Pearl, *California Attorney Fee Awards* (2d Ed. Cal. Cont. Ed. Bar 1994) Section 12.10).

2. Section 1036 is made applicable, as judicial decisions already establish, in any inverse condemnation proceeding in which the court renders judgment for the plaintiff.

3. The words "or that attorney" are deleted from Section 1036 to eliminate inadvertent confusion in the language of Section 1036 that has misled some courts to conclude erroneously that they lacked authority to resolve litigation expense issues when the parties settled liability issues but failed to settle litigation expense issues. The Legislature's intent is to clarify that the court retains authority to resolve litigation expense issues in the event the parties cannot resolve litigation expense issues by settlement. It is not the Legislature's intent to limit the parties' right to resolve litigation expense issues by settlement if they can do so.

4. It is not the Legislature's intent to affect either the substantive law of inverse condemnation liability or the rule that Section 1036 confers discretion upon courts in determining the amount of litigation expenses awarded. (*E. G., City of Los Angeles v. Waller* (1979) 90 Cal. App. 3d 766, 780; *Parker v. City of Los Angeles* (1974) 44 Cal. App. 3d 556, 567-568).
