The road has been closed to vehicular traffic recently by the Department of Parks and Recreation. Prior to the closure this year by the Department, the road was apparently open to vehicles for all but a few months during the summer.

It was our intent in Budget Item #3790-001-1263 that the road be open to vehicular traffic year round except during June 1 and September 30, inclusive. Thus, the policy would be to essentially reinstate the summer month closure in effect prior to the year round closure to vehicles recently enacted.
