Re: AB 175

Dear Dotson: A question has arisen as to the exact procedures that are to be used in transferring firearms, pursuant to the provisions of AB 175, from a law enforcement agency to the family of the deceased officer. While the legislation requires that any firearm that is transferred be rendered inoperable, the firearm still has a frame or receiver which would make the firearm subject to numerous sections of the Penal Code.

As you know, California Penal Code Section 12070 requires that any one who sells, loans, or transfers a firearm (including the frame or receiver of a firearm) needs a state firearm dealer's license.

At the same time, section 12070 contains numerous exemptions from the licensing requirement.

In addition, Penal Code section 12072(d) provides that the sale, loan, or transfer of a firearm (including the frame or receiver of a firearm) must be conducted through a state licensed firearm dealer or a local sheriff's department.

As with Penal Code section 12070, section 12078 also exempts numerous firearm transactions from dealer processing or local sheriff's department processing if various conditions are complied with.

Among the transactions exempted from dealer licensing, as well as the normal firearm processing requirements, are so-called "operation of law" transactions. (See Penal Code section  $12070\,(b)\,(1)$  and  $(c)\,(2)$ , and Penal Code section  $12078\,(i)$  and  $(t)\,(2)\,.)$ 

Section 12078(i) exempts "operation of law transactions" from dealer/law enforcement processing if the person receiving the firearm is not prohibited by Section 12021 or 12021.1 of this code, or Section 8100 or 8103 of the Welfare and Institutions Code, from

possessing firearms.

In addition, in the case of pistols, revolvers, or other firearms capable of being concealed on the person, the person receiving the firearm (within 30 days of taking possession) must forward (by prepaid mail or personal delivery) to the Department of Justice, a report containing information regarding the individual taking possession of the firearm, how title or possession was obtained and from whom, as well as a description of the firearm in question.

"Operation of law transactions" include, but are not limited to, dispositions of firearms where a person receives title of a firearm as part of an estate proceeding, or the firearm is received by the

surviving spouse. However, the list is not exclusive.

It is my understanding, and intention, that the firearm transactions covered by AB 175 are "operation of law" transactions. As such, if the procedures set forth in Section 12070(b) (1) AND 12078(i) are complied with, then both the employing agency, and the family member of the deceased officer receiving the firearm, are in full compliance with Penal Code section 12070 and 12072(d).

In addition, AB 175 exempts these transactions from the basic firearm safety certificate requirement. Although certain "operation of law" transactions require the receiver to obtain this safety certificate, the exemption contained in AB 175 is designed to obviate the need for a certificate since the firearm has been rendered inoperable.

Please be assured, that should there be a need for further, clarifying legislation to make the foregoing clear, I will be happy to carry such legislation next year.
