MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 834

Governor's Office, Sacramento July 22, 1995

To the Members of the California Assembly:

I am returning Assembly Bill No. 834 without my signature.

This bill would seek to clarify the law which automatically abolishes land use restrictions enforceable as "powers of termination" after thirty years unless the restrictions are also enforceable as "equitable servitudes" to provide that restrictions enforceable as "covenants running with the land" are also not automatically abolished.

While the effort to clarify arcane laws which distinguish between interests in real property is commendable this bill raises more questions then it resolves.

The issue regarding whether 1982 legislation terminated certain venerable covenants is clearly in dispute. This bill proclaims that it did not. If this is a correct analysis of the law that portion of AB 834 would prove to be a nullity providing its proponents with no legal rights that they do not already enjoy.

If AB 834 is incorrect in its proposed restatement of the law it seeks to reinstate already terminated covenants in an arguably unconstitutional fashion.

More problematic than either of these possibilities which would ultimately be resolved by the courts is the exception created by the bill wherein any person who acquired real property between January 1, 1989 and January 1, 1996 relying to his or her detriment on the non-existence of a restriction on the property and without real or constructive knowledge of the restriction would not be subject to such restriction.

This bill would accordingly do what it declares current law does not, it would extinguish covenants which have existed for many years as they relate to an unidentified group of properties sold during a seven year period based on the subjective beliefs of the purchasers. While I am sympathetic to the concerns of the proponents of this bill its impacts are not quantifiable and therefore not justifiable.
