Rogan, the distinguished Assembly Member from the 43rd District, is drawing to a close his tenure in the California State Assembly, and it is appropriate at this time to highlight his many achievements and to commend him for his illustrious record of service to the State of California; and

WHEREAS, A native Californian, James E. Rogan was born in San Francisco, graduated from the University of California at Berkeley with a bachelor's degree in political science, and received his law degree from the University of California, Los Angeles, School of Law, where he was a member of the UCLA Law Review; and

WHEREAS, He obtained experience as a civil litigation attorney with the private firm Lillick McHose and Charles (now Pillsbury Madison and Sutro), was an adjunct professor of trial advocacy at Southwestern University School of Law, and taught criminal law at Glendale University College of Law and Glendale Community College; he also has served as a member of the Selective Service System since his appointment to that commission by President Reagan in 1981; and

WHEREAS, He brought great credit to himself during the six years he worked as a Los Angeles County Deputy District Attorney, where, in addition to his assignment in the "Hardcore Gang Murder Unit," he prosecuted scores of rapists, robbers, child molesters, drug traffickers, and murderers, and was lead prosecutor in the internationally publicized "Lamb Funeral Home" scandal; and

WHEREAS, In 1990 he was appointed by Governor George Deukmejian to the Glendale Municipal Court, distinguishing himself as the youngest sitting judge in the state, and he served as the presiding judge of the Glendale Municipal Court from 1993 to 1994; and

WHEREAS, He won a special election to the California State Assembly in May 1994 as representative of the 43rd District, representing the Cities of Glendale and Burbank, portions of North Hollywood and Toluca Lake, and the Los Feliz and Atwater Village

portions of the City of Los Angeles, and he was reelected to office the following November; and

WHEREAS, In January 1996 Assembly Member Rogan was unanimously elected by his colleagues in the Republican Caucus to serve as Assembly Majority Leader and he also was named by California Journal magazine as the overall best legislator in the Assembly; and

WHEREAS, He distinguished himself as Chair of the Select Committee on the Arts, the Entertainment Industry and Software and Technology, and as a member of the Public Safety Committee; and

WHEREAS, As an Assembly Member, he has authored legislation including the "10-20-Life" bill, which stiffens prison sentences for criminals who use a firearm in the commission of a felony; the "Bad Time Credits" bill, which adds prison time for an inmate who misbehaves while in prison; the "Sexually Violent Predator" bill, which establishes a civil commitment process to remand sexual predators to a mental facility once their prison sentences are complete, in order to keep them off the streets; and the "Bill Limitation" bill, which cuts in half the number of bills legislators may introduce in a session; and

WHEREAS, James Rogan and his wife, Christine, are the proud parents of twin daughters, Dana and Claire; and

WHEREAS, Through his professional, public, and community activities, he has made a significant impact on the people of the 43rd Assembly District and the State of California, and he will be sorely missed by those individuals with whom he has been associated; now, therefore, be it
