Members of the Assembly: As required by Chapter 716, Statutes of 1992, the Bureau of State Audits presents its audit report concerning the way the Department of Health Services (department) processes reimbursement requests for certain prescribed drugs under the California Medical Assistance Program (Medi-Cal). These requests are known as drug treatment authorization requests (TARs). This report concludes that even though the number of drug TARs received by the department has increased dramatically during the six months from December 1994 through May 1995, the department made significant improvement in meeting tĥe requirements to process drug TARs and has reduced its backlog of unprocessed drug TARs. As discussed in our February 1995 report, the department hired 79 new workers. This increased staffing has enabled the department to process more drug TARs and to implement the department's new policy, added in April 1995, that requires the processing of all drug TARs within one working day. The greatest impact is on the processing of mailed-in drug TARs since. prior to April 1995, the department required mailed-in drug TARs to be processed within five working days.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Department of Education's (department) administration of child care and development program funds, its contracting policies and procedures, and its oversight of child care contractors during fiscal years 1991–92 through 1993–94. This report concludes that the department did not maximize its efforts to ensure the delivery of child care and development services; therefore, millions of dollars in state and federal funds remain unspent. Furthermore, the department did not always ensure independence in the awarding of contracts, did not consistently process appeals of contract awards, and did not consistently recommend adverse actions against contractors that submitted late audit reports. Finally, the department's process for reviewing annual audit reports submitted by contractors was deficient.

Veto Message—Assembly Bill No. 182

Governor's Office, Sacramento August 3, 1995

To the Members of the California Assembly:

I am returning Assembly Bill No. 182 without my signature.

This bill would authorize local governments to adopt an ordinance to provide shopping cart retrieval and storage services in a specified manner.

The theft of shopping carts from retailers is a common problem in California which often results in blight and public safety problems for many communities. As such, it is unlawful to remove a shopping cart from the retailers premises.

AB 182 would inappropriately preempt local control in dealing with this matter. Shopping cart retrieval is an integral part of cities and counties efforts to eliminate public nuisance in many areas, and a service for which they clearly should be reimbursed. However, this measure provides that a local government may not recover any cost if there is a private shopping cart retrieval service operating in an affected area.

Clearly, there is no justification for local government to overcharge a retailer when retrieving the shopping cart. Yet, when the retrieval does occur local jurisdictions actual cost should be reimbursed.

The purpose and intent of AB 867 is to allow a county to seek reimbursement of up to \$5,000 from its own residents, in addition to availing itself to current law, in situations where the search and rescue was necessitated by a person acting in a manner they knew to be in violation of the law, or acting with wanton and reckless disregard for their safety.

I have submitted this letter in order to provide clarification of the provisions in AB 867.
