#### Legislative Intent-Assembly Bill No. 882

August 24, 1995

Dear Madame Speaker: This letter clarifies the intent of AB 882, which I authored. The bill concerns the admissibility in sexual offense cases of evidence that the defendant has committed another sexual offense or offenses.

AB 882 is modeled on Rules 413-15 of the Federal Rules of Evidence, and adapts the principle of these rules to the framework of California law. A number of statements were generated in the

legislative history of the federal rules that can be consulted and relied on for explanation concerning the background, rationale, and effect of this reform. See 140 Cong. Rec. H8991–91 (daily ed. Aug. 21, 1994) (statement of Rep. Susan Molinari, principal House sponsor of Fed. R. Evid. 413–15): Karp, Evidence of Propensity and Probability in Sex Offense Cases and Other Cases, 70 Chicago-Kent L. Rev. 15 (1994) (text of address by author of Fed. R. Evid. 413–15): 137 Cong. Rec. S3238–42 (daily ed. March 13, 1991) (analysis statement accompanying proposal of Fed. R. Evid. 413–15 in S. 635).

Specific explanation concerning AB 882, its relationship to prior California Law, and the need for its enactment in California, appears in an article by the legislation's sponsor, Attorney General Dan Lungren: Stopping Rapists and Child Molesters by Giving Juries All the Facts—Reforms in Federal and California Law (published in

1995 in *Prosecutor's Brief*, volume XVII, no. 2, at 13–14, 23.)

During its consideration by the legislature, AB 882 was the subject of hearings before the Assembly Committee on Public Safety, the Senate Committee on Criminal Procedure, and the Senate Committee on Judiciary. Three amendments were adopted to the

bill in connection with these hearings.

During the hearing before the Assembly Committee on Public Safety, the language of the new S 1108 of the Evidence Code was amended to provide explicitly that evidence of other offenses within the scope of the section is not subject to S 1101's prohibition of evidence of character or disposition. This makes it clear that S 1108 permits courts to admit such evidence on a common sense basis—without a precondition of finding a "non-character" purpose for which it is relevant—and permits rational assessment by juries of evidence so admitted. This includes consideration of the other sexual offenses as evidence of the defendant's disposition to commit such crimes, and for its bearing on the probability or improbability that the defendant has been falsely or mistakenly accused of such an offense.

During the hearing before the Senate Committee on Criminal Procedure, the bill was amended to delete the direct application of the new S 1108 to civil actions. Nevertheless, the reform remains valuable to civil litigants who seek redress for sexual offenses. In cases where a criminal conviction for the underlying act is obtained with the help of new S 1108, normal collateral estoppel principles will generally foreclose the defendant from denying his commission of

the offense in subsequent civil suit.

During the hearing before the Senate Committee on Judiciary, an amendment was adopted to provide explicitly that Evidence Code S 352 remains applicable to evidence offered under the new S 1108. While S 1108 explicitly supersedes S 1101's prohibition of evidence of character or disposition within its scope of application, it does not supersede other provisions of the Evidence Code, such as normal restrictions in hearsay and the court's authority to exclude evidence presenting an overriding likelihood of prejudice under S 352. Cf. People v. Ewoldt, 7 Cal. 4th 380, 404–08 (1994): People v. Balcom 7 Cal. 4th 414, 426–27 (1994) (S 352 balancing in relation to admission of evidence of other sexual offenses under S 1101).

The amendment adopted at the Judiciary Committee hearing simply makes this point explicit in relation to \$352. The reform does,

however, affect the practical operation of S 352 balancing, because admission and consideration of evidence of other sexual offenses to show character or disposition would be no longer treated as intrinsically prejudicial or impermissible. Hence, evidence offered under S 1108 could not be excluded on the basis of S 352 unless "the probability that its admission will . . . create substantial danger of undue prejudice" (or other adverse effects identified in S 352) substantially outweighed its probative value concerning the defendant's disposition to commit the sexual offense or offenses with which he is charged and other matters relevant to the determination of the charge. As with other forms of relevant evidence that are not subject to any exclusionary principle, the presumption will be in favor of admission.

At the hearing before the Judiciary Committee, there was discussion whether more exacting requirements of similarity between the charged offense and the defendant's other offenses should be imposed. The decision was against making such a change, because doing so would tend to reintroduce the excessive requirements of specific similarity under prior law which AB 882 is designed to overcome, *see* Lungren, *supra*, at 14, and could often prevent the admission and consideration of evidence of other sexual offenses in circumstances where it is rationally probative. Many sex offenders are not "specialists", and commit a variety of offenses which differ in specific character.
