House Resolution No. 77

By Assembly Member Pringle

Relative to commending the Honorable Phillip Isenberg.

WHEREAS, The Honorable Phillip Isenberg, the distinguished and able Assembly Member from the 9th Assembly District, is drawing to a close his tenure with the California State Assembly following 14 years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendations; and

WHEREAS, Phillip Isenberg was first elected to the California State Assembly in 1982 and, while serving with distinction as an Assembly Member, has authored laws to allow people who have been denied health insurance because of previous medical conditions to buy state-backed coverage; he wrote the law establishing the toughest smoking prevention programs in the nation; he was the author of landmark legislation to reform the sometimes shocking conditions in California nursing homes; and he authored legislation to require nonprofit health care corporations, when they convert to for-profit status, to reimburse the taxpayers for their years of tax-free benefits; and

WHEREAS, He also authored laws to promote agricultural water conservation, expand wetland areas, and protect Mono Lake, has been a leading advocate of restructuring state and local government to concentrate program responsibility, eliminate duplication, and improve public service, and has emerged as a creative mediator in negotiations to resolve the state's increasingly intractable budget problems; in addition, he and his staff have helped hundreds of people to solve problems with unresponsive government agencies; and

WHEREAS, Assembly Member Isenberg served as Chairperson of the Assembly Judiciary Committee from 1989 to 1995, and authored landmark legislation mandating efficiencies in court operations, providing state funding for trial courts, and increasing public access; and he further distinguished himself as a member of the Assembly Committees on Banking and Finance; Consumer Protection, Governmental Efficiency and Economic Development; Health; Housing and Community Development; Public Safety; Ways and Means; and Water, Parks, and Wildlife; and

WHEREAS, He also has served as a member of the California Constitution Revision Commission, the California Judicial Council, the RAND Advisory Board on immigration, and the Milbank Foundation's Primary Care Project; and

WHEREAS, Prior to his election to the California State Assembly, Phillip Isenberg was a member of the Sacramento City Council and served as Mayor of Sacramento for two terms; and

WHEREAS, A native of Gary, Indiana, Phillip Isenberg moved with his family to California at a young age, was educated in the Sacramento public schools and graduated from El Camino High School; he received a bachelor's degree in social science from California State University at Sacramento and a law degree from the University of California at Berkeley, Boalt Hall Law School; and

WHEREAS, He served in the California National Guard and was a civilian employee at McClellan Air Force Base; after law school, he was Chief Consultant for the former Assembly Ways and Means Committee before becoming a founding partner in the law firm of Blackmon, Isenberg and Moulds; and

WHEREAS, Through his professional, public, and community activities, he has made a significant impact on the people of the 9th Assembly District and the State of California, and he will be sorely missed by those individuals with whom he has been associated; now, therefore, be it

Resolved by the Assembly of the State of California, That the Members take great pride in honoring Assembly Member Phillip Isenberg for his outstanding service to the people of 9th Assembly District and the people of California during his tenure as a Member of the Legislature, and extend to him heartiest best wishes for happiness and success in his future endeavors; and be it further

Resolved, That the Chief Clerk of the Assembly transmit a suitably prepared copy of this resolution to the Honorable Phillip Isenberg.

Dear Tom: As you well know, on October 13, 1995, Governor Wilson vetoed AB 767. In his veto message, the Governor explained that he opposed linking the future disposal of the Department of Health Services property at 2151 Berkeley Way to the preservation of wetland and grassland areas at the University of California's Richmond Field Station. Following the Governor's veto you introduced AB 2324 that would provide the University an opportunity to acquire the Department of Health Services property at 2151 Berkeley Way separate from any plans for a preserve. As Chancellor, I greatly appreciate your persistent efforts to facilitate the University's acquisition of the Berkeley Way property. Prior to the introduction of AB 2324, you asked the Berkeley campus to express in writing our plans for preservation of the wetlands and grasslands. I am pleased to inform you that a wetland/grassland reserve is and will continue to be incorporated into our long-range plans concerning the Richmond Field Station.

The Berkeley campus administration has gained a much better understanding of the nature of the wetland and native grassland habitats at the Richmond Field Station as a result of recent studies engendered by the Master Plan process and by earlier efforts to identify a site for the Department of Health Services adjacent to these areas. These studies have confirmed and underscored the importance of this habitat for both its intrinsic and its research value. Accordingly, our commitment to its future, as embodied in the

Master Plan, is the following:

- The area of prime coastal prairie grasses (approximately 8.7 acres, see Figure 3) is recognized in the plan as a viable native plant community and development in that area is forbidden in the plan. This increasingly rare habitat provides the opportunity for a variety of research and field teaching activities for the Berkeley campus. The native coastal prairie grassland is particularly valuable because of its proximity to the marsh, mud flat and bay habitats at the Richmond Field Station site. The coastal prairie grassland is situated in the center of one of the largest contiguous open areas on the property. As a result, the Master Plan does not permit development of the coastal prairie grassland area and, instead, sets aside this area as a valuable reserve.
- The Master Plan includes a number of other measures to assure the preservation of the coastal prairie grassland for its

teaching, research, and habitat value. These preservation measures include:

- (a) Requiring guidelines to protect the coastal prairie grassland;
- (b) Provisions for the installation of fencing, as necessary, to allow small animals to pass to and from the coastal prairie grassland but to discourage human intrusions in the area;
- (c) Preservation of a grassland corridor along the western boundary of the Richmond Field Station property between the prime grassland, and the marsh and shoreline open space areas, in order to allow a variety of fauna to migrate between the two areas; and
- (d) Provisions for the installation of a low-lying bridge or a system of culverts under the proposed extension of Lark Drive to the Western property line, to allow the migration of small animals and insects under the roadway and along the grassland corridor.

The Master Plan includes a site diagram (see enclosed Figure 6, Master Plan Elements) that graphically depicts the grassland/wetland areas to be preserved. I would note that the plans for the Richmond Field Station, including those for the reserve, will continue to be subject to the review and approval of the UC Board of Regents. Environmental review of the draft Master Plan is scheduled to restart this fall and approval by the Board of Regents is anticipated in the fall of 1997. However, I assure you that the Berkeley campus administration is committed to both the letter and the spirit of this preservation strategy, and that the Master Plan provides the campus with the necessary policy framework to protect the prime wetlands and grassland areas at the Richmond Field Station.

We thank you for introducing a bill to address the disposition of the 2151 Berkeley Way site and for all your efforts on this project.
