A bill to implement the Budget Bill or otherwise related to the budget shall not be considered or acted upon on the floor of the Assembly until 48 hours after the bill has been in print and 24 hours after analyses of the bill prepared by the Legislative Analyst and the Assembly Floor Analysis Unit have been placed upon the desks of the Members.

The Members appointed to a committee on conference of the Budget Bill shall not vote in favor of the report of the committee unless the budget proposed by the report balances expenditures with anticipated revenues, provides for a reserve of not less than 3 percent of the total of all expenditures for which appropriations are made in the Budget Bill for the fiscal year, and is based upon no internal or external borrowing by the state other than borrowing that the Budget Bill or another statute would require to be repaid during that fiscal year.
