Veto Message—Assembly Bill No. 105

Governor's Office, Sacramento September 2, 1995

To the Members of the California Assembly:

I am returning Assembly Bill No. 105 without my signature.

This bill would require the Departments of Education and Health Services to jointly develop and make available information regarding chronic fatigue syndrome. This information would describe how an individual diagnosed with this syndrome could qualify and receive special education services as well as services available under Section 504 of the Rehabilitation Act of 1973.

This bill is unnecessary. School districts already have the ability to provide services for students afflicted with this syndrome. Further, the Department of Education could develop information for parents and teachers regarding chronic fatigue syndrome if it determines that this is a priority.

Veto Message—Assembly Bill No. 1912

Governor's Office, Sacramento September 2, 1995

To the Members of the California Assembly:

I am returning Assembly Bill No. 1912 without my signature.

This bill would establish, until December 31, 1997, a technical advisory committee to make recommendations on using data collected by the Cancer Registry to publish an annual report providing risk adjusted five-year survival rates for breast and prostate cancer based on the patient's source of health care coverage.

Establishing a new statutory advisory committee is unnecessary and contrary to efforts to streamline government. Moreover, the information that would be produced by this bill would create a misleading and unreliable reference guide for consumers choosing a plan. Long term outcome statistics are important in evaluating the merit of a specific treatment or a plan's quality of care. A five-year survival statistic bears little relationship to the care a plan is providing. Finally, the care provided by the plan may have no meaningful correlation to survival rates.
