Dear Mr. Speaker: At our request, the Assembly today placed Assembly Bill No. 482 on the inactive file. This letter is to clarify our intent with regard to that action.

The decision to place AB 482 on the inactive file follows an agreement reached between the Council for Private Postsecondary and Vocational Education and Coleman College. The agreement is set forth as follows:

- 1) Coleman College indicates that on August 31, 1995, it filed with the Council an application for exemption pursuant to Section 94303 of the Education Code, and an application for approval to operate pursuant to Section 94310. The Council will consider Coleman College to be a candidate for approval, with legal authorization to operate, until completion and disposition of these applications.
- Coleman College will cease conferral of certificates of completion, and exclusively confer associate, baccalaureate, and graduate degrees in order to satisfy the exemption standards of Section 94303.
- 3) Upon receipt of all necessary information and records from Coleman College, the Student Aid Commission will perform a recalculation simulation for the college's cohort default rates within a reasonable time period. The Council will use the recalculated rate in lieu of the rates previously reported by the United States Department of Education for the purpose of determining any eligibility for exemption pursuant to Section 94303.

With these actions, enactment of AB 482 as an urgency measure will become unnecessary. The policy proposed in the legislation will be considered next year by the Committee on Higher Education as it considers the comprehensive sunset review of the Private Postsecondary and Vocational Education Reform Act of 1989.

State Budget

18. The Speaker, the Committee on Rules, and a leader selected by each of the two party caucuses shall jointly adopt a plan to encourage early discussions on the state budget in the Committee on Budget. Those early discussions shall include interim hearings during the fall when the administration is formulating the budget for the ensuing fiscal year.

The Committee on Budget shall set spending goals for each subcommittee prior to subcommittee hearings.

The committee on conference of the Budget Bill shall not be appointed until the Assembly has debated and passed a proposed Budget Bill. Between the date upon which a committee on conference of the Budget Bill is appointed and the date the Assembly adopts the report of the conference committee, the Speaker, the leaders selected by the two party caucuses, and the chairperson on the conference committee from the Assembly shall provide weekly briefings to the Members on the progress of the conference committee deliberations, for which purpose the Assembly shall resolve itself into a Committee of the Whole.

A bill to implement the Budget Bill or otherwise related to the budget shall not be considered or acted upon on the floor of the Assembly until 48 hours after the bill has been in print and 24 hours after analyses of the bill prepared by the Legislative Analyst and the Assembly Floor Analysis Unit have been placed upon the desks of the Members

Any bill that is approved by a committee on conference of the Budget Bill shall not

No Budget Bill shall be considered or acted upon on the floor of the Assembly unless it does all of the following:

(1) Balances expenditures with anticipated revenues.

- (2) Provides for a reserve of not less than 3 percent of the total of all expenditures for which appropriations are made in the Budget Bill for the fiscal year, or provides for a reserve of not less than 1 percent and a specific plan to phase in a reserve of at least 3 percent within three years.
- (3) Is based upon no internal or external borrowing by the state other than borrowing that the Budget Bill or another statute would require to be repaid during that fiscal year.
