**Proclamation by Governor Gavin Newsom**  
**2025–26**  
**FIRST EXTRAORDINARY SESSION**  
*(Convened December 02, 2024)*  
**Amended to Expand Call**  
*(January 13, 2025)*

---

**WHEREAS** on November 6, 2024, it became clear that Donald J. Trump has won election as President of the United States, setting the stage for President–Elect Trump to assume office for a second term on January 20, 2025; and

**WHEREAS** the track record of the first Trump Administration, combined with the statements made by President–Elect Trump on the campaign trail, as well as statements and policy papers issued by individuals close to his campaign and by Republican congressional leadership, indicate the consequences of his presidency for California may be significant and immediate, including:

- Continuing the assault on reproductive freedom by limiting access to medication abortion, expanding conscience objections for employers and providers, and pursuing a national abortion ban;
- Undoing clean vehicle policies that are critical to combating climate change and dismantling other long–standing environmental protections for clean air and clean water;
- Repealing Deferred Action for Childhood Arrivals (DACA) and reinstating immigration policies that lead to family separations;
- Withholding disaster response funding and individual assistance for victims of disasters as political retribution; and
- Politicizing grant programs to commandeer state and local governmental resources for federal purposes; and

**WHEREAS** during President–Elect Trump’s first term, California developed a successful roadmap for fighting back and standing up for our State’s values and our people’s constitutional rights, including filing more than 120 lawsuits challenging actions taken by the Trump Administration; and

**WHEREAS** lawyers from the Attorney General’s Office and my office have been preparing for a potential second Trump term for more than a year, and we are marshaling the arguments and evidence needed to be ready to challenge in court unconstitutional and unlawful federal policies, and to mount robust and vigorous defenses of California’s laws, policies and programs, on issues critical to Californians; and

**WHEREAS** preparing to litigate regressive potential actions on these major policy issues with the urgency and comprehensiveness called for in this moment necessitates ensuring the state’s legal apparatus is sufficiently resourced; and

**WHEREAS** these extraordinary circumstances require the Legislature of the State of California to be convened in a special session.

**NOW, THEREFORE, I, GAVIN NEWSOM**, Governor of the State of California, in accordance with Section 3(b) of Article IV of the California Constitution, hereby convene the Legislature of the State of California to assemble

in extraordinary session in Sacramento, California, on the 2nd day of December 2024, at a time to be determined, for the following purposes:

To consider and act upon legislation necessary to:

a. Provide additional funding to the California Department of Justice and other agencies, departments, boards, and offices within the Executive Branch to support the ability to immediately file affirmative litigation challenging actions taken by the incoming Trump Administration, defend against litigation or enforcement actions brought by the incoming Trump Administration, and take administrative action authorized under state law to mitigate the impacts of actions by the incoming Trump Administration.

b. Make conforming changes to existing law consistent with the preceding paragraph.

**I FURTHER DIRECT** that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

**Proclamation by Governor Gavin Newsom  
Call of the Extraordinary Session Expanded  
(January 13, 2025)**

---

**WHEREAS** on November 7, 2024, I issued a Proclamation calling a special session of the Legislature to take prompt action to respond to threats made by the incoming federal administration regarding federal funding and other potential harms to the people of California; and

**WHEREAS** on January 7, 2025, I proclaimed a State of Emergency to exist in Los Angeles and Ventura Counties due to fire and windstorm conditions that have now caused multiple fires, including the Palisades, Eaton, Hurst, Lidia, Sunset, and Woodley Fires; and

**WHEREAS** on January 8, 2025, President Biden approved a Major Disaster Declaration to make federal funding available to affected individuals in Los Angeles County, and to state, tribal and local governments for debris removal and emergency response costs; and

**WHEREAS** this federal assistance will be critical, but the debris removal and emergency response funding is provided on a reimbursement basis, and the State must have sufficient funds available to cover all necessary costs without delay; and

**WHEREAS** a number of schools were destroyed or damaged due to these fires, and technical assistance from the State will help them rebuild as quickly as possible; and

**WHEREAS** this emergency underscores the need to accelerate the availability of bond funding to be prepared for firestorms, building on the billions of dollars California has invested over the last five years toward those purposes.

**NOW, THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, in accordance with Section 3(b) of Article IV of the California Constitution, hereby AMEND my Proclamation dated November 7, 2024, convening the Legislature of the State of California to assemble in extraordinary session in Sacramento, California, on the 2<sup>nd</sup> day of December 2024, by adding the following additional purposes for the session:**

To consider and act upon legislation necessary to:

c. Provide funding to support ongoing response and recovery efforts in the areas affected by the January 2025 emergency conditions in the Los Angeles area, as follows:

i) Provide \$1 billion to augment state emergency response funding to promptly fund costs, which should be eligible for reimbursement by the Federal Emergency Management Agency, for emergency response, cleanup, and recovery of areas affected by the January 2025 emergency conditions in the Los Angeles area.

ii) Provide funding to the Division of the State Architect and other state agencies, as appropriate, to expedite technical assistance to local

educational agencies regarding efforts to rebuild and repair schools affected by the January 2025 emergency conditions in the Los Angeles area.

iii) Accelerate availability of \$1.5 billion in funding for greater preparedness against the growing threats of firestorms and windstorms and other natural disasters, to complement and add to disaster response and recovery funding provided by the federal government, including the continuance of existing efforts.

d. Make conforming changes to existing law consistent with this proclamation and to enable rapid deployment of funds provided under the preceding Paragraph.

**I FURTHER DIRECT** that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.
