Dear Speaker Núñez and Assemblyman McCarthy: After careful consideration, I write to inform you of my decision to recuse myself from Joint Legislative Audit Committee proceedings that involve the review and investigation of the practices of the Office of Secretary of State Kevin Shelley. I greatly appreciate my recent appointment to the committee but I think that it is in everyone's best interest that I not participate in these particular hearings. I would furthermore request that an appropriate replacement be made in my stead.

As you may know, my Capitol Director, Erin Muth Guerrero, is married to Willie Guerrero, who currently serves in the Office of the Secretary of State. I deeply care for and respect Erin and Willie as personal friends and dedicated public servants, and have for a long time now. I know that both Erin and Willie can and would conduct themselves in an exemplary manner, with integrity, probity, and discretion as the JLAC deliberations commence.

I am mindful, however, that even the most minor or remote public perception of a conflict of interest—stemming from Willie and Erin's marriage and my presence on the Joint Legislative Audit Committee during its upcoming hearings—could be misconstrued or even used to undermine confidence in the committee proceedings. It is my sincere desire to make a genuine contribution to a full and fair JLAC investigation. Although I know that I and every person in my office can and will conduct themselves properly at all times, I feel that an even higher standard is required.

Public confidence in the actions of their elected officials is vital every single day that a Member holds office. At a time when the Legislature conducts a formal investigation of a statewide elected official, not to mention a former Member of the Legislature, that standard is raised higher still. With these thoughts in mind, together with the singular goal

of a JLAC investigative process which may be viewed by all Californians as a model of fairness and objectivity, that I believe I must recuse myself from hearings pertaining to the Secretary of State.

I thank you both for the confidence and respect implicit in my appointment to the Joint Legislative Audit Committee, and I sincerely hope you understand that my request to be removed from the hearings involving the Secretary of State stems solely from my earnest desire to best serve the institution of the California State Assembly, the people of the state of California, and the 25th Assembly District that I am so honored and privileged to represent.
