REMARKS BY CHIEF SERGEANT AT ARMS

Speaker Rendon extended congratulations to Alisa Buckley on behalf of the Members of the Assembly, whereupon Alisa Buckley, Chief Sergeant at Arms of the California State Assembly arose and addressed the assemblage.

HONORED GUESTS WELCOMED

Chief Sergeant at Arms Alisa Buckley acknowledged friends and former colleagues from the Sacramento Police Department present in the Chamber, and was joined at the rostrum by her mentor Pete Willover, retired Sacramento Police Detective.

REMARKS BY SPEAKER RENDON

Members, it is significant that we have acted today, to install Sue Parker as Chief Clerk and Alisa Buckley as Chief Sergeant at Arms.

Ninety-nine years ago this week, the Assembly elected Hattie Jewell Anderson as an officer of the House. Anderson, who was the Minute Clerk, was the first woman elected to become an Assembly officer. This happened less than six months after the 19th Amendment became the law of the land, guaranteeing American women the right to vote.

We live in an age where women hold many important offices for California. Women serve as Senate President pro Tempore, Lieutenant Governor, State Controller, State Treasurer, United States Senator and Speaker of the House of Representatives. It makes it hard to believe, and somewhat shameful, that their nationwide voting rights took effect fewer than 100 years ago.

It is more shameful that we still do not have a fair complement of women in these seats in front of me. We can only benefit from increasing the numbers of women in this house. We should all work for that.

It is refreshing, now, to have women take charge of these two Assembly offices that have always been occupied by men. One of those offices seems to have always been occupied by Dotson Wilson, but the historians tell me that's not true. Let me also note that the Assembly's third non-member office, Chaplain, is also currently held by a woman: the Rev. Patti Oshita.

Chief Clerk Sue Parker, Dotson Wilson's successor, has her own strong history in the Assembly. She has worked in the Clerk's office for nearly three decades and has served as Assistant Chief Clerk for more than a decade. Going into the future, we can depend on Sue Parker to run this critical office with an even hand, deep knowledge, wide understanding of the institution and a dependable loyalty to the Assembly.

Thank you, Sue, and congratulations.

On the other hand, Chief Sergeant Alisa Buckley is a newcomer to the Legislature. That does not mean we are any less happy to have her in this position, which seems to grow in importance as state policy critics in California find new ways, and old, to exercise the First Amendment.

Chief Buckley comes to us with an extensive background in law enforcement, including two decades with the Sacramento Police Department. She will demonstrate that experience, working in this building to ensure that Legislators, Capitol Staff and Capitol visitors are safe as we publicly conduct the business of California.

Alisa Buckley is also the first Asian Pacific Islander Chief Sergeant in our history, by virtue of her Filipino heritage.

Alisa, congratulations and thanks for joining the Assembly team.
