# MESSAGES FROM THE GOVERNOR

The following budget message from the Governor was received and ordered printed in the Journal:

January 10, 2011

To the Senate and the Assembly of the California Legislature:

I hereby submit to you my proposed Budget for 2011–12.

This Budget proposes a far-reaching realignment of government functions by restoring to local government authority to make decisions that are best made closer to the people, not in Sacramento. My plan also envisions reorganizing state government to make it more efficient and save scarce tax dollars by consolidating or eliminating functions. Since it will take some time to fully implement these changes, I propose to ask the voters for a five-year extension of several current taxes so that we can restructure in an orderly manner with minimal disruption.

If we make the tough decisions now and put our accounts in order, we will again make California the national leader in job creation as our nation slowly recovers from the current recession.

We begin 2011, after the longest budget stalemate in the history of California, with a budget gap of more than \$25 billion. Short-term measures and gimmicks adopted in recent years did not solve our problem and in fact made it worse. This Budget closes our short-term budget gap and also eliminates projected future deficits.

The Budget focuses on the core functions of government and maintains essential services. Nowhere is this more important than in our public schools, which have taken big cuts in recent years.

Along with responsibilities returned to local government through the proposed realignment, the Budget provides dedicated and ongoing revenues.

As California's economy begins to recover—and recover it will—our restructuring plan will make California government more transparent, efficient and responsive to the people.

This is a tough budget for tough times. I look forward to working with you and taking decisive action without delay.

#### REMARKS BY SPEAKER OF THE ASSEMBLY

Members, I rise to request that we adjourn in memory of the men, women and young girl who were killed this weekend in Arizona. They are: John Roll, age 63, who served as a federal judge; Gabriel Zimmerman, age 30, who was an aide to Congresswoman Giffords; Dorwan Stoddard, age 76; Phyllis Schneck, age 79; Dorothy Morris, age 76; and most tragically of all, Christina-Taylor Green, age 9, who was born on September 11, 2001 and had just been elected President of her class at school when her life was taken.

By now, we are all familiar with the terrible events that occurred on Saturday. We are praying for the swift and speedy recovery of Congresswoman Giffords and the other victims who survived the shooting. And we mourn the men and women who lost their lives that day.

Certainly, much of the news has focused on the condition of Congresswoman Giffords, and on the deaths of her aide and Judge Roll. They died while serving our country in an official capacity. But we must also remember that the other victims of this shooting were also performing a service to our country. They were taking part in government as active and informed citizens. As a nation whose laws are derived from the just consent of the governed, the highest duty each and every one of us has is to embrace our roles as citizens and to take part in the governing process. The fact that these men and women died in performance of that duty deeply saddens us all, and compounds this tragedy further.

As public servants, every single person under this dome knows that the privilege to serve the people comes with both risks and rewards, and this shooting is a terrible reminder of the risks. But we must remember that the ultimate reward is the opportunity to make our state and country a better place through our service. And that must continue to be our focus.

We live in an era of unprecedented economic pain. Millions of Californians and Americans are suffering on a daily basis, and as the events on Saturday showed all too clearly, sometimes that suffering leads to tragedy. While it will be some time before we fully understand the events leading up to the shooting, we already understand the pain our nation is suffering, and our duty to bring relief to that suffering.

Forty years ago, our nation was wracked by division and anger. Though the causes were very different, the effects were the same, and one victim of that violence was Dr. Martin Luther King, Jr. On the evening of his assassination, Senator Robert Kennedy was scheduled to address a rally in Indianapolis. It fell to him to inform the audience that Dr. King had been shot and killed. He understood the gravity of his words, and I believe they have a special resonance today. Senator Kennedy said:

"What we need in the United States is not division; what we need in the United States is not hatred; what we need in the United States is not violence and lawlessness, but is love and wisdom, and compassion toward one another, and a feeling of justice toward those who still suffer within our country . . .

We can do well in this country. We will have difficult times. We've had difficult times in the past. And we will have difficult times in the future. It is not the end of violence; it is not the end of lawlessness; and it's not the end of disorder.

But the vast majority of . . . people in this country want to live together, want to improve the quality of our life, and want justice for all human beings that abide in our land."

As we are called upon to solve challenges unprecedented in the modern history of California, we need to remember that the ties that bind us are far stronger than the small issues that divide us.

As we honor our fellow citizens who will be laid to rest, let us remember that fact and rededicate ourselves to serving our nation and state. That is the highest honor we can pay to the men and women who gave their lives on Saturday.

Members, I request you join me in adjourning in memory for these men and women, and I ask that the Assembly observe a moment of silence. Thank you.
