To the Senate and the Assembly of the California Legislature:

I submit for your consideration the Governor's Budget for 2001-02.

We begin this New Year with justifiable pride in our past accomplishments, while facing new challenges in the coming year. California's economy continued its remarkable expansion in the year 2000, and we look ahead to sustaining this growth in 2001 and beyond.

We've made great progress in the past two years on our top priority of improving public schools and the education they provide for our children. This budget continues California on the path to excellence in education by calling for a significant lengthening of the school year in middle schools, undertaking a dramatic expansion of our highly

ASSEMBLY BILL NO. 93—Pescetti. An act to add Chapter 6 (commencing with Section 75480) to Part 8 of Division 21 of the Water Code, relating to water.

ASSEMBLY BILL NO. 94—Daucher and Rod Pacheco. An act to add Section 40714.7 to the Health and Safety Code, relating to electricity.

ASSEMBLY BILL NO. 95—Cardenas. An act making appropriations for the support of the government of the State of California and for several public purposes in accordance with the provisions of Section 12 of Article IV of the Constitution of the State of California, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 96—Aroner (Coauthor: Senator Perata). An act relating to the Emery Unified School District, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 97—Zettel. An act to amend Section 2972 of the Penal Code, relating to prisoners.

ASSEMBLY BILL NO. 98—Zettel. An act to add Section 11375.5 to the Health and Safety Code, relating to controlled substances.

ASSEMBLY BILL NO. 99—Zettel. An act to amend Section 52262 of the Education Code, relating to education technology.

ASSEMBLY BILL NO. 100—Simitian. An act to amend and repeal Section 41204.1 of the Education Code, and to add Section 97.42 to, and to repeal Section 97.43 of, the Revenue and Taxation Code, relating to local government finance.

ASSEMBLY BILL NO. 101—Alquist. An act to add Chapter 4.5 (commencing with Section 128300) to Part 3 of Division 107 of the Health and Safety Code, relating to health.

ASSEMBLY BILL NO. 102—Rod Pacheco. An act to amend Sections 11165.5, 11165.7, 11166.5, and 11167 of, and to add Section 11166.05 to, the Penal Code, relating to crime reporting and declaring the urgency thereof, to take effect immediately.
