ASSEMBLY BILLS**

The following bills were introduced and read the first time:

**ASSEMBLY BILL NO. 151—Burke and Cooper (Coauthors: Low and Rubio).** An act relating to greenhouse gases.

**ASSEMBLY BILL NO. 152—Gallagher (Coauthor: Senator Nielsen).** An act to amend Section 6027 of the Penal Code, relating to corrections.

**ASSEMBLY BILL NO. 153—Chávez.** An act to amend Section 3003 of the Government Code, and to amend Section 532b of the Penal Code, relating to military fraud.

**ASSEMBLY BILL NO. 154—Levine.** An act to add Chapter 16 (commencing with Section 1425) to Title 10 of Part 2 of the Penal Code, relating to prisoners.

**ASSEMBLY BILL NO. 155—Gomez.** An act to add Section 51226.8 to the Education Code, relating to pupil instruction.
