**INTRODUCTION AND FIRST READING OF
ASSEMBLY BILLS**

The following bills were introduced and read the first time:

ASSEMBLY BILL NO. 109—Feuer. An act to add and repeal Section 5420 of the Business and Professions Code, relating to outdoor advertising.

ASSEMBLY BILL NO. 110—Smyth (Coauthor: Senator Runner). An act to amend Section 33204.4 of the Public Resources Code, relating to parks and open space.

ASSEMBLY BILL NO. 111—Niello (Coauthors: DeVore and Jeffries) (Coauthors: Senators Cox, Huff, and Runner). An act to amend Section 17144.5 of the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.

ASSEMBLY BILL NO. 112—Beall. An act to amend Sections 100001.5, 100161, 100163, and 100164 of the Public Utilities Code, relating to transportation.

ASSEMBLY BILL NO. 113—Portantino. An act to add Section 118.2 to the Streets and Highways Code, relating to highways, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 114—Carter. An act to add Section 237 to the Welfare and Institutions Code, relating to juveniles.
