## INTRODUCTION AND FIRST READING OF ASSEMBLY BILLS

**ASSEMBLY BILL NO. 237—Gray.** An act to add Chapter 9.4 (commencing with Section 3140) to Division 4 of Title 1 of the Government Code, relating to public employment.

**ASSEMBLY BILL NO. 238—Voepel.** An act to amend Section 14900.1 of the Vehicle Code, relating to vehicles.

ASSEMBLY BILL NO. 245—Chiu (Coauthors: Lee, Levine, and Santiago) (Coauthor: Senator Wiener). An act to add Section 66271.4 to the Education Code, relating to educational equity.

ASSEMBLY BILL NO. 246—Quirk and Mathis (Coauthors: Bauer-Kahan and Lee). An act to repeal and add Section 7110 of the Business and Professions Code, relating to contractors.

ASSEMBLY BILL NO. 247—Ramos. An act relating to small business.
