**ASSEMBLY BILL NO. 133—Hagman.** An act to add Section 60063 to the Education Code, relating to instructional materials.

**ASSEMBLY BILL NO. 134—Logue and Mansoor.** An act to amend Section 6254 of the Government Code, relating to public records.

**ASSEMBLY BILL NO. 135—Buchanan.** An act to amend Section 44664 of the Education Code, relating to public school teachers.

**ASSEMBLY BILL NO. 136—Buchanan.** An act to amend Section 17466 of the Education Code, relating to school facilities.

**ASSEMBLY BILL NO. 137—Buchanan.** An act to amend Section 51212 of the Education Code, relating to pupil instruction.

**ASSEMBLY BILL NO. 138—Olsen (Coauthors: Achadjian and Wilk).** An act to add Section 66025.2 to the Education Code, relating to public postsecondary education.
