**ASSEMBLY BILL NO. 219—Voepel.** An act to amend Section 5901 of the Vehicle Code, relating to vehicles.

ASSEMBLY BILL NO. 220—Bonta, Gonzalez, and Wicks (Coauthors: Bauer-Kahan, Chiu, Gabriel, Limón, Petrie-Norris, and Blanca Rubio) (Coauthors: Senators Jackson and Skinner). An act to amend Section 89513 of the Government Code, relating to the Political Reform Act of 1974.

**ASSEMBLY BILL NO. 224—Brough.** An act to amend Section 11750 of the Health and Safety Code, relating to public health.

**ASSEMBLY BILL NO. 225—Brough.** An act to amend Section 89513 of the Government Code, relating to the Political Reform Act of 1974.
