**ASSEMBLY BILL NO. 31—Portantino and Jeffries.** An act to amend Sections 218, 17207, and 24347.5 of, and to add Sections 195.158, 195.159, and 195.160 to, the Revenue and Taxation Code, relating to disaster relief, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.
