**INTRODUCTION AND FIRST READING OF
ASSEMBLY BILLS**

The following bills were introduced and read the first time:

ASSEMBLY BILL NO. 1612—Alanis. An act to add Article 7.5 (commencing with Section 41984) to Chapter 3 of Part 4 of Division 26 of the Health and Safety Code, and to add Section 21080.82 to the Public Resources Code, relating to environmental hazards.

ASSEMBLY BILL NO. 1613—Wilson. An act to amend Section 5090.24 of the Public Resources Code, and to add Chapter 9 (commencing with Section 38610) to Division 16.5 of the Vehicle Code, relating to vehicles.

ASSEMBLY BILL NO. 1614—Dixon. An act to amend Section 21204 of the Vehicle Code, relating to vehicles.

ASSEMBLY BILL NO. 1615—Nguyen. An act to amend Section 32000 of the Penal Code, relating to firearms.

ASSEMBLY BILL NO. 1616—Davies. An act to add and repeal Section 709 of the Military and Veterans Code, relating to veterans.

ASSEMBLY BILL NO. 1617—Alanis. An act to amend Section 25218.9 of the Health and Safety Code, relating to hazardous waste.

ASSEMBLY BILL NO. 1618—Rogers. An act to add Chapter 9.7 (commencing with Section 18750) to Part 6 of Division 9 of the Welfare and Institutions Code, relating to food insecurity.

ASSEMBLY BILL NO. 1619—Valencia (Coauthor: Chen). An act to amend Section 31521 of the Government Code, relating to public employees' retirement.

HOUSE RESOLUTION NO. 76—Schultz (Coauthors: Haney, Harabedian, Jackson, and Krell). Relative to affordable homeownership.
