PRAYER

Upon invitation of Speaker pro Tempore Mullin, the following prayer was offered by Assembly Member Weber, of the 79th Assembly District.

Father, When I was a child I heard about this man, who had lived 969 years, named Methuselah; and the only thing they said was that he lived 969 years, and then he died. We have spent the weekend honoring the legacy of Dr. Martin Luther King, Jr., who lived only 39 years, but look at what he did in 39 years. As we reflect on his work, it becomes profoundly clear that this young man—at the age of 26—became a national leader carrying the burden of race for this nation and the world. And, that he had only 13 short years to do this important work.

Father, as we think of our work, let us approach it with the same sense of urgency as Dr. King. Most of us have only 12 short years here in the Legislature, almost the same amount of time Dr. King had to challenge and win some of the great victories of this nation. Let us see these 12 years as "King Years" and use them as if there is no other time left for us: to address the challenges of our day; to correct some wrongs; strengthen our state where it has been challenged and weakened; and build a strong foundation based on principles of fairness, justice, equality, and prudence.

Let us approach the important work of this Assembly as Dr. King—with a sense of urgency and a sense of NOW—so that our legacy will not be merely one of having counted our 12 years and then leaving, as was Methuselah. Let us make every moment count so that whether we have one term or six terms, the people of this great state will remember what we did and not say, "She served six terms and then left."—AMEN.
