**ASSEMBLY BILL NO. 138—Nation.** An act to amend Sections 10126, 10780.5, and 20103.8 of the Public Contract Code, relating to public contracts.

**ASSEMBLY BILL NO. 139—Calderon.** An act relating to public utilities, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.

**ASSEMBLY BILL NO. 140—Strom-Martin.** An act to amend, repeal, and add Sections 270, 275, 276 of, and to add and repeal Section 276.5 of, the Public Utilities Code, relating to public utilities.

**ASSEMBLY BILL NO. 141—Cardoza.** An act to amend Section 272 of the Penal Code, relating to crime.
