The following bills were introduced and read the first time:

**ASSEMBLY BILL NO. 165—Carter.** An act to amend Section 18000 of the Business and Professions Code, and to amend Section 14013 of, and to add Sections 14001 and 14013.2 to, the Unemployment Insurance Code, relating to microenterprises.

ASSEMBLY BILL NO. 166—Lieu (Coauthors: Portantino, John A. Pérez, V. Manuel Pérez, Saldaña, and Torlakson) (Coauthor: Senator DeSaulnier). An act to amend Sections 525 and 526 of, and to add and repeal Section 526.1 of, the Harbors and Navigation Code, relating to vessels.
