PRAYER

Upon invitation of Speaker pro Tempore Mullin, the following prayer was offered by Assembly Chaplain Rev. Patti Oshita:

Please join me in a moment of reflection.

All of humanity and all life are not separate from the environment of our one planet Earth. We know this. In our minds we know this to be undeniably true. From the early 1960s, the original astronauts from Mercury 7 often felt transformed when they first saw the Earth from space. This deeply moving experience was felt from our very first astronauts to the international astronauts who have had the opportunity to serve on the Space Station. The experience was often described as “transforming.”

Dr. Mark Shelhamer, a Johns Hopkins University medical professor, who served as the chief scientist for human research at NASA’s Johnson Space Center, said, “You will hear this from astronauts not infrequently: that they have felt the . . . oneness of humanity.”

Colonel Chris Hadfield, who served as the Commander of the International Space Station, often shared the incredible experience of seeing the Earth from space. With this experience, he suddenly understood, that the entire world was a single system. From space, he could literally see the interconnectedness of all life.

Astronaut Russell Schweickart from the Apollo 9 mission, in sharing his experience of seeing the Earth as they orbited, said, “The whole process of ‘what it is you identify with’ begins to shift. You begin to recognize that your identity is with that whole thing (the whole planet). You look down there and you can’t imagine how many borders and boundaries you cross . . . and you don’t even see them. There you are (looking down where)—hundreds of people (are) killing each other over some imaginary line that you’re not even aware of and you can’t see.”

What so many astronauts have seen and felt, we know is true. Their Wisdom Eyes have opened; and they know that we must care for the life-giving environment of our one planet Earth; and that our shared human experience has no borders.
