**INTRODUCTION AND FIRST READING OF  
ASSEMBLY BILLS**

The following bills were introduced and read the first time:

**ASSEMBLY BILL NO. 197—Stone.** An act to amend Sections 11155, 11155.1, and 11257 of the Welfare and Institutions Code, relating to CalWORKs.

**ASSEMBLY BILL NO. 198—Wieckowski.** An act to amend Sections 703.140, 704.010, 704.100, 704.113, 704.720, and 704.960 of, and to add Section 704.111 to, the Code of Civil Procedure, relating to exempt property.

**ASSEMBLY BILL NO. 199—Holden.** An act to add Chapter 7 (commencing with Section 58595) to Division 21 of the Food and Agricultural Code, and to amend Sections 4330 and 4331 of the Government Code, relating to institutional purchasers of agricultural products.

**ASSEMBLY BILL NO. 200—Hagman.** An act to amend Section 42238.1 of the Education Code, relating to education finance.

**ASSEMBLY BILL NO. 201—Holden.** An act to amend Sections 14010, 14021, and 14025 of the Corporations Code, relating to corporations.

**ASSEMBLY BILL NO. 202—Donnelly (Coauthors: Grove, Hagman, Harkey, Jones, and Wagner).** An act to add Section 38010 to the Education Code, and to amend Section 6254 of the Government Code, relating to school security.
