**PRAYER**

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Reverend Bob Oshita:

I grew up the 3rd of 4 children. My older brother, Gerald, was 6 years older. When I was 6, he was 12. When I was 12, he was 18. There were too many years between us to really play together as children, but I admired him. He was always just so much wiser and talented. I recall in Jr. High School, dropping off my books at home, before going out to meet my friends. He happened to be home and inquired, "Where are you going?" I replied, "Out to play." He asked me, "Did you finish your homework?" I smugly said, "Yes. It's all done!" Then he asked, "Are you getting all A's?" I reluctantly said, "Well . . . no . . ." He let that sink in, then added, "You say you've finished your homework, but it's clear that you haven't finished studying." There was no denying what he had to say was true.

When I was in college, I recall him commenting on something I said. I responded quickly in defense. After a few moments, he interrupted me, softly saying, "Calm down. I'm just sharing my opinion. I'm not trying to change your mind or prove you wrong." I said, "I'm not arguing!" Then, with a smile, he said, "Look at us. Who's the one raising his voice?" Again, he made me assess my behavior.

In 1992, my brother Gerald suffered a stroke and died exactly 4 weeks after his 50th birthday. It was then that I realized he had always been my unconscious preview to life. As a young child, I knew I would someday be doing the things he did. Watching him, prepared me for the changes and challenges to come. But I was not prepared to lose him so suddenly.

That feeling is perhaps the last and greatest lesson he gave me. He taught me that there is no guarantee that we will have the chance to grow old together. He taught me that if there are people who have helped us, thank them now. And to those we love, hold them close now. Not tomorrow, not the next time we see them. This to me, is the path to live my life with few regrets. Please join me on this path of caring and gratitude and few regrets.

Namo Amida Butsu—Let us try to live with kindness and gratitude beyond words.
