ASSEMBLY BILL NO. 1723—Lieu and Emmerson. An act to amend Section 240 of, and to add Section 1390 to, the Evidence Code, relating to evidence.

ASSEMBLY BILL NO. 1724—Chesbro (Coauthor: Senator Aanestad). An act to add Section 42283.3 to the Education Code, relating to necessary small schools, and declaring the urgency thereof, to take effect immediately.
