**ASSEMBLY BILL NO. 12—Bill Berryhill and Galgiani (Principal coauthor: Olsen) (Principal coauthors: Senators Berryhill and Cannella).** An act to repeal and add Section 96.11 of the Revenue and Taxation Code, relating to local government finance, and declaring the urgency thereof, to take effect immediately.
