Dear Mr. Wilson: On January 31, 2014, the Asian & Pacific Islander Legislative Caucus recognizes the Lunar New Year. This marks the beginning of the holiday, as many Asian & Pacific Islander American (APIA) communities around the world celebrate the Year of the Horse.

California is home to 5.5 million APIAs, and Lunar New Year is predominantly celebrated by the Chinese, Korean, and Southeast Asian American residents of California. Each community has their own unique traditions they carry out in observance of the holiday. Generally, residents view the holiday as a time to renew family ties and to start the year off with a clean slate.

In some cultures, legend states that Buddha promised gifts of peace, happiness, and long life to all animals that came to honor him. To thank the animals for their loyalty, Buddha created a calendar of twelve years, dedicating one year to each animal. People born in the Year of the Horse tend to be independent, perceptive, artistic, and patient.

The celebration of Lunar New Year in California illustrates the state's rich cultural diversity and commitment to racial, religious, and cultural tolerance.
