#### **Cal Grant Day**

WHEREAS, California is home to many very bright, hard-working students who cannot afford to attend college, yet do not meet the eligibility requirements to qualify for financial aid; and

WHEREAS, California's burgeoning economy dictates a need for a highly educated work force, including an ever-increasing demand for skilled workers with technological backgrounds; and

WHEREAS, the total student debt increased by approximately 350 percent in the 1990s, while grant aid has decreased from 48 percent of the total annual financial assistance sum in California to just 38 percent; and

WHEREAS, the average family income for college graduates is \$85,000, while families with only a high school education usually earn just \$48,000; and

WHEREAS, Because of the dramatically broadened scope of eligibility requirements in this magnificent program, striking new opportunities are now available for countless students who may not have previously qualified for financial assistance to attend college; and

WHEREAS, the new Cal Grant program guarantees a financial aid award to every worthy student who is financially and academically eligible; and I encourage all eligible students to apply for a Cal Grant award by the March 2, 2001 deadline; and

WHEREAS, the Cal Grant Program is the first such program in the nation to guarantee need-based financial aid to students; and February is "College Awareness Month;" now, therefore be it

*RESOLVED*, that I, Cruz M. Bustamante, Acting Governor of the State of California, do hereby declare Friday, February 2, 2001 as Cal Grant Day in the State of California, and encourage all Californians to join me in recognizing the need to provide an affordable college education to all of California's worthy students.
