Legislative Intent—Assembly Bill No. 1096

Dear Chief Clerk Parker: Last year, I authored AB 1096, *Chapter 296, Statutes of 2021*. My intent with authoring AB 1096 was strictly to remove the term ‘alien’ from state laws and replace the term with more appropriate language.

It recently came to my attention that AB 1096 unintentionally eliminated a bias requirement in Gov. Code 1031. Upon further review, it seems AB 1096 was introduced with an outdated version of Gov. Code 1031, which did not include the additional language from AB 846, which created the bias requirement in Gov. Code 1031. As such, AB 1096 inadvertently reverted GC 1031 to the pre-AB 846 version.

To clarify this change was not the intention of AB 1096.
