This report concludes that the department has taken important steps to implement controls ensuring that all program costs are appropriate and that only approved witnesses receive program services. However, the program policies and procedures display some shortcomings, that as the program increases in size, could lead to inconsistencies and backlogs in processing claims.

Members of the Assembly: As required by the California Welfare and Institutions Code, Section 19640.5, the Bureau of State Audits presents its audit report concerning its fiscal audit of the Department of Rehabilitation's (department) Business Enterprise Program for the Blind (program). This report concludes that the financial condition of the program is sound, and although the department has improved its financial management of the program, some opportunities for further improvement exist. Specifically, the surplus in the Vending Stand Account—Special Deposit Fund appears excessive. Additionally, the department could increase vending machine income more than 35 percent by establishing contracts for all vending machines on state and federal property.
