PROCLAMATION***Census Awareness Day
in Los Angeles***

WHEREAS, there are only 52 days until the count begins in the 2000 federal decennial census, which represents the first great challenge of the new millennium; and

WHEREAS, after the 1990 census, it was determined that an estimated 835,000 Californians, including 350,000 of the state's children, were not counted; and

WHEREAS, as a result of the undercount, California lost approximately \$2.2 billion in federal money that it should have received, totaling \$2,660 lost for each man, woman and child not counted; and

WHEREAS, a similar undercount in the 2000 census would mean that more than one million people would not be counted in California, likely costing the state billions of dollars in needed revenue; and

WHEREAS, the City of Los Angeles, the Office of the Mayor, and the State of California through the California Complete Count Committee, have joined forces to present a community-based census forum; now therefore be it

RESOLVED, That I, Cruz M. Bustamante, Acting Governor of the State of California, do hereby proclaim Thursday, February 10, 2000 as Census Awareness Day in Los Angeles.
